ORDINANCE NO. 6675

AN ORDINANCE TO AUTHORIZE, ON A TEMPORARY BASIS, THE WAIVER OF CERTAIN BUSINESS LICENSE-RELATED FEES AND CHARGES FOR QUALIFYING NEW BUSINESSES TO BE ESTABLISHED WITHIN THE LAS VEGAS MEDICAL DISTRICT, AND TO PROVIDE FOR OTHER RELATED MATTERS.

Sponsored by: Councilwoman Lois Tarkanian

Summary: Authorizes, on a temporary basis, the waiver of certain business license-related fees and charges for qualifying new businesses to be established within the Las Vegas Medical District.

THE CITY COUNCIL OF THE CITY OF LAS VEGAS DOES HEREBY ORDAIN AS FOLLOWS:

SECTION 1: In order to encourage the opening of certain types of new businesses within the Las Vegas Medical District and in accordance with the provisions of this Ordinance, the Department of Planning may waive specified types of business license-related fees and charges for qualifying new businesses that are located within the Las Vegas Medical District. For purposes of this Section 1:

(A) The Las Vegas Medical District is the area so designated within LVMC Chapter 19.09.

(B) The specified types of business license-related fees and charges that may be waived are as set forth in Section 2 of this Ordinance.

(C) "Qualifying new businesses" are those set forth in Section 3 of this Ordinance.

SECTION 2: The types of business license-related fees and charges that may be waived pursuant to Section 1 of this Ordinance are:

(A) The license processing fee chargeable under LVMC 6.02.085.

(B) Initial semiannual or annual license fees, whether flat fees or based on gross sales, that are chargeable under LVMC Chapter 6.04 (but not Chapter 6.50).

(C) Origination charges that are chargeable under LVMC Chapter 6.50.

(D) License renewal fees for the first renewal period regarding licenses whose fees are

2 SECTION 3: Qualifying new businesses concerning which a waiver may be granted
3 pursuant to Section 1 are the following:

4 (A) Restaurant service bar, beer and wine room, or beer/wine/cooler on-sale
5 establishment.

6 (B) Adult day care facility.

7 (C) Clinic or laboratory.

8 (D) Convenience store.

9 (E) Drugstore.

10 (F) Employment agency or contract labor service.

11 (G) Express delivery service.

12 (H) Food service or café.

13 (I) Food specialty or grocery store.

14 (J) Hospital.

15 (K) Hotel, resort hotel, motel, or residence hotel (including those offering single rooms).

16 (L) Instruction and learning service.

17 (M) Personal service.

18 (N) State licensed medical professional service.

19 (O) Health and fitness center.

20 (P) Sports center.

21 (Q) Restaurant.

22 (R) Executive suites. For purposes of this Ordinance, "executive suites" means the
23 leasing of office space in which the lease transaction includes the provision of related office services and
24 amenities, such as office furniture, utilities and internet service.

25 (S) Post-secondary technical training school.

26 (T) Career/health school or career college.

- (U) EMS training.
- (V) Massage school.
- (W) Nursing school.
- (X) Vocational school.
- (Y) Mortuary.
- (Z) Special care facility (ambulatory/hospice).
- (AA) Theater.
- (BB) Transitional living facility.
- (CC) Vocational rehabilitation counselor.

SECTION 4: A waiver referred to in Section 1 of this Ordinance may be granted pursuant to a qualifying waiver application that is filed with the Department between the effective date of this Ordinance and two years thereafter. Any waiver of the types of fees described in Subsections (A) to (C), inclusive, of Section 2 shall be conditioned upon activation of the business license within the following time periods after the submittal of a qualifying waiver application:

- (A) One year, for a business to be located within an existing structure; or
- (B) Two years, otherwise.

SECTION 5: Notwithstanding any provision of Title 6 of the Las Vegas Municipal Code to the contrary, a business license concerning which a waiver has been granted pursuant to this Ordinance and which has been activated:

- (A) May not be sold or transferred to a third party, which includes any change of ownership or change of principal; and
- (B) May not be transferred to a new location unless the location is within the Las Vegas Medical District, the location is approved in accordance with the requirements of LVMC Title 19, and the license holder remains the same.

SECTION 6: For purposes of Sections 4 and 5 of this Ordinance:

- (A) "Activation of a business license" means that the license has been issued and the

1 business authorized by the license has opened for business operation.

2 (B) "Qualifying waiver application" means an application for waiver that is:

3 (1) Submitted in connection with a business license application; and

4 (2) Accompanied by a copy of one of the following documents:

5 (a) An application for a special use permit that has been filed with the
6 Department of Planning pursuant to LVMC Title 19, if a special use permit is required;

7 (b) A conditional use verification that has been filed with the
8 Department of Planning pursuant to LVMC Title 19, if the use is one that is permitted as a conditional use;
9 or

10 (c) Written verification from the Department of Planning that the use is
11 permitted as a matter of right pursuant to LVMC Title 19.

12 SECTION 7: If any section, subsection, subdivision, paragraph, sentence, clause or phrase
13 in this ordinance or any part thereof is for any reason held to be unconstitutional or invalid or ineffective by
14 any court of competent jurisdiction, such decision shall not affect the validity or effectiveness of the
15 remaining portions of this ordinance or any part thereof. The City Council of the City of Las Vegas hereby
16 declares that it would have passed each section, subsection, subdivision, paragraph, sentence, clause or phrase
17 thereof irrespective of the fact that any one or more sections, subsections, subdivisions, paragraphs,
18 sentences, clauses or phrases be declared unconstitutional, invalid or ineffective.
