ORDINANCE NO. 6696

AN ORDINANCE TO AMEND LVMC TITLE 13 TO ADD A NEW CHAPTER 60 TO AUTHORIZE THE REMOVAL AND DISPOSITION OF SIGNS AND ATTENTION GAINING DEVICES THAT HAVE BEEN PLACED ON CITY PROPERTY OR IN PUBLIC RIGHTS-OF-WAY ILLEGALLY, AND TO PROVIDE FOR OTHER RELATED MATTERS.

Sponsored by: Councilman Cedric Crear

Summary: Amends LVMC Title 13 to add a new Chapter 60 to authorize the removal and disposition of signs and attention gaining devices that have been placed on City property or in public rights-of-way illegally.

THE CITY COUNCIL OF THE CITY OF LAS VEGAS DOES HEREBY ORDAIN AS FOLLOWS:

SECTION 1: Title 13 of the Municipal Code of the City of Las Vegas, Nevada, 1983 Edition, is hereby amended by adding thereto a new chapter, designated as Chapter 60 and consisting of Sections 10 and 20, reading as follows:

13.60.010: For purposes of this Chapter:

“Attention gaining device” means any streamer, pennant, propeller, inflatable sign, tethered balloon, portable sign, bunting or other artificial device, figure, shape, color, sound, light or exhibit, whether live, animated or still, that is intended to attract attention.

“City property” means any real property owned or leased by the City and dedicated to City purposes.

“Public right-of-way” means any area dedicated to public use for public street purposes. The term includes without limitation roadways, parkways, alleys and sidewalks, and includes the definition of that term as found in LVMC 19.18.020.

“Sign” means any device, fixture, placard, structure or other medium, including its structure and component parts, that uses any color, form, graphic, illumination, symbol or writing to advertise, announce the purpose of, or identify the purpose of a person or entity, or to communicate information of any kind to the public.

1 **13.60.020:** (A) Subject to the provisions of Subsection (B), a law enforcement officer or an officer
2 or employee of the City assigned to the implementation or enforcement of this Chapter may remove and
3 dispose of any sign or attention gaining device that, in violation of the provisions of Title 19 or any other
4 provision of this Code, has been erected or placed on City property or within a public right-of-way, or has
5 been attached to a tree, pole, or other structure on City property or within a public right-of-way.

6 (B) If an officer or employee determines that a sign or attention gaining device removed
7 pursuant to Subsection (A) is of sufficient value and character that the person responsible for its placement
8 is likely to reclaim the item, or that the sign or device has a potential resale value greater than one hundred
9 dollars, the sign or device shall be retained for at least twenty days for purposes of being reclaimed, and then
10 may be either destroyed or disposed of in accordance with LVMC Chapter 4.16.

11 SECTION 2: If any section, subsection, subdivision, paragraph, sentence, clause or phrase
12 in this ordinance or any part thereof is for any reason held to be unconstitutional or invalid or ineffective by
13 any court of competent jurisdiction, such decision shall not affect the validity or effectiveness of the
14 remaining portions of this ordinance or any part thereof. The City Council of the City of Las Vegas hereby
15 declares that it would have passed each section, subsection, subdivision, paragraph, sentence, clause or phrase
16 thereof irrespective of the fact that any one or more sections, subsections, subdivisions, paragraphs,
17 sentences, clauses or phrases be declared unconstitutional, invalid or ineffective.

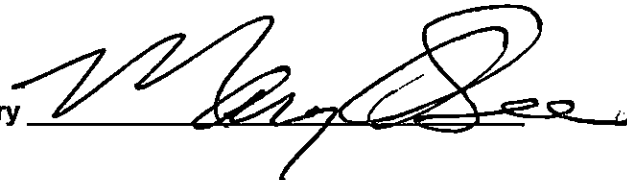

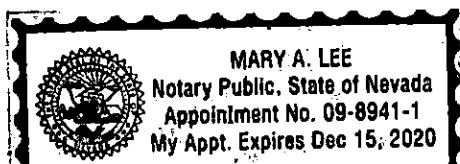

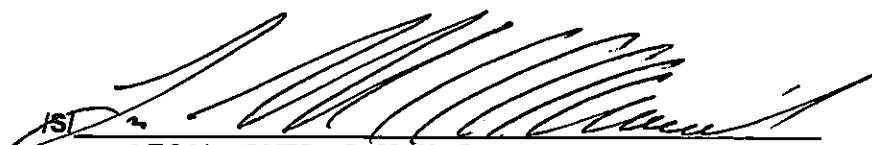
