4 AN ORDINANCE TO AMEND LVMC CHAPTER 6.50 TO ESTABLISH A NEW ALCOHOL  
5 DELIVERY SUPPORT SERVICE ALCOHOLIC BEVERAGE LICENSE CATEGORY, TOGETHER  
6 WITH ASSOCIATED REQUIREMENTS AND LIMITATIONS; EXPAND THE CATEGORIES UNDER  
WHICH A BUSINESS CAN EXERCISE AN ANCILLARY ALCOHOLIC BEVERAGE LICENSE; AND  
PROVIDE FOR OTHER RELATED MATTERS.

Summary: Amends LVMC Chapter 6.50 to  
8 establish a new alcohol delivery support service  
9 alcoholic beverage license category, together with  
associated requirements and limitations, and  
10 expand the categories under which a business can  
exercise an ancillary alcoholic beverage license.

11 THE CITY COUNCIL OF THE CITY OF LAS VEGAS DOES HEREBY ORDAIN AS  
12 FOLLOWS:

13 SECTION 1: Title 6, Chapter 50, of the Municipal Code of the City of Las Vegas, Nevada,  
14 1983 Edition, is hereby amended by adding thereto a new section, designated as Section 95, reading as  
15 follows:

16 **6.50.095:** (A) An alcohol delivery support service alcoholic beverage license authorizes a person  
17 to deliver alcoholic beverages on behalf of an establishment that sells alcoholic beverages for off-premise  
18 consumption. Each alcoholic beverage delivered pursuant to this license:

19 (1) Must be in the original manufacturer-sealed container or a sealed container  
20 qualifying under LVMC 6.50.085(C);

21 (2) Must have been purchased from the establishment by a consumer for  
22 delivery to the premises requested by the purchaser;

23 (3) Must have been purchased by telephone, internet or other electronic means;

24 and

25 (4) Is subject to the sales and delivery restrictions set forth in LVMC  
26 6.50.100(B).

1 (B) Before a license described in this Section may be issued, the applicant must establish  
2 and provide to the Department for Director approval a delivery policy designed to ensure that the  
3 requirements of this Section and State law in relation to the delivery of alcoholic beverages are met.

4 The delivery policy must include at a minimum:

- 5 (1) Protocols to ensure that drivers are twenty-one years or older;
- 6 (2) Alcohol awareness training for drivers, which includes at a minimum:
  - 7 (a) Reviewing relevant State laws, including those that prohibit buying  
8 for or selling to minors;
  - 9 (b) Reviewing possible criminal and civil penalties that might be  
10 imposed for the violation of laws and ordinances governing the licensee's operation;
  - 11 (c) Checking for valid identification documents, recognizing false  
12 identification documents, and refusing delivery in the case of suspicious or false identification documents;
  - 13 (d) Verifying and tracking the personal information of recipients, as  
14 well as any recipient signatures that may be obtained; and
  - 15 (e) Identifying and refusing delivery to intoxicated recipients.
- 16 (3) Procedures to ensure that each delivery address is in a jurisdiction in which  
17 the delivery of alcohol is permitted and that the delivery will be in accordance with the applicable delivery  
18 regulations of that jurisdiction;
- 19 (4) Procedures to ensure that deliveries are not made to the location of any  
20 nonrestricted gaming, as proscribed by LVMC 6.50.100(B)(4);
- 21 (5) Procedures to document how delivery data will help ensure compliance,  
22 with such documentation to be made available for audit when requested by the City;
- 23 (6) Procedures for conducting background checks regarding drivers; and
- 24 (7) Procedures documenting how certain delivery information is gathered and  
25 maintained that includes at a minimum the items described in LVMC 6.50.100(B)(2).

26 (C) Each holder of an alcohol delivery support service alcoholic beverage license shall

1 maintain a list of the establishments with which the holder has entered into contracts for delivery service  
2 pursuant to this Section.

3 (D) The delivery policy referred to in Subsection (B) must be maintained in force and a  
4 copy produced to the Department or Metro upon request.

5 (E) Each licensee is responsible for the conduct and violations of any driver it employs,  
6 whether the driver is an employee or independent contractor and regardless of any contractual arrangement  
7 between the selling establishment and the driver.

8 SECTION 2: Title 6, Chapter 50, Section 100, of the Municipal Code of the City of Las  
9 Vegas, Nevada, 1983 Edition, is hereby amended to read as follows:

10 **6.50.100:** (A) An ancillary license authorizes the sale of alcoholic beverages for [specialty]  
11 particularized sales, instruction or tasting as follows:

12 (1) Internet and Related Sales. A person [that offers alcoholic beverages for  
13 sale at a grocery store in excess of five thousand square feet pursuant to a package liquor license may sell  
14 alcoholic beverages by delivery to a purchaser's premises pursuant to an internet purchase order placed by  
15 the purchaser subject to sales and delivery restrictions in LVMC 6.50.100(B), below.] licensed pursuant to  
16 this Chapter to sell alcoholic beverages for off-premise consumption may offer and sell such beverages by  
17 telephone, internet or other electronic means, and may provide for the delivery of such beverages to the  
18 premises requested by the purchaser, either through direct delivery by the licensee or by means of an alcohol  
19 delivery support service that is licensed pursuant to LVMC 6.50.095 and that meets the requirements of that  
20 Section and Subsection (B) of this Section.

21 (2) Instructional Wine-Making. A person authorized to sell alcoholic beverages  
22 pursuant to a package liquor license may instruct persons regarding the making of wine provided that such  
23 licensee first acquires, and maintains in good standing, any required State license or permit.

24 (a) Wines made during the instructional process may be served by the  
25 glass for consumption on the premises of the instructional establishment to those persons involved with the  
26 instructional process.

1 (b) Notwithstanding the provisions of LVMC 6.50.430, persons who  
2 have made wine during an instructional process pursuant to this Section may place such wine in bottles or  
3 containers and remove them from the instructional establishment, but only for their personal use.

4 (3) Tasting. A person authorized to sell alcoholic beverages pursuant to a  
5 package liquor, wholesale general or beer/wine/cooler off sale license may provide the tasting of wines and  
6 beers, and cordials or liqueurs (if permitted pursuant to the person's license) pursuant to the following  
7 conditions:

8 (a) The sample must not exceed one-half ounce per drink;

9 (b) The samples must be served on the premises of the licensee for  
10 educational purposes or to promote the sale of packaged alcoholic beverages;

11 (c) The samples shall not be offered in conjunction with a meal at a  
12 restaurant;

13 (d) Persons offering samples of alcoholic beverages must be employees  
14 of the licensee and the person must possess a valid work card; and

15 (e) Bottles of wines, beers, cordials or liqueurs opened for tasting shall  
16 not be sold, otherwise distributed or given away.

17 (4) Individual Access. An owner or beneficial owner of a hotel that is  
18 authorized to sell alcoholic beverages pursuant to a hotel lounge bar license, or an owner or beneficial owner  
19 of a sports arena or convention center that is authorized to sell alcoholic beverages pursuant to a general on-  
20 sale or a tavern license may sell alcoholic beverages by individual access pursuant to the following  
21 conditions:

22 (a) For individual access in a hotel room:

23 (i) The hotel must provide a full-service restaurant that serves  
24 meals no less than twelve hours every day, room service of meals to all rooms no less than twelve hours  
25 every day, and no less than one full-time security guard on duty at all times;

26 (ii) The hotel must provide a secure means by which an adult

1 transient guest may control the access to the secured cabinet or refrigerator from minors that occupy the hotel  
2 room; and

3 (iii) The adult transient guest shall not permit any minors that  
4 are occupying the hotel room to access the secured cabinet or refrigerator.

5 (b) For individual access in a booth or viewing suite at a convention  
6 center or sports arena:

7 (i) The alcoholic beverages for the booths or viewing suites  
8 shall be provided to the tenant by the licensee. Notwithstanding any other provision of this Chapter, a tenant  
9 of the booth or viewing suite shall not bring any alcoholic beverages into the booth or viewing suite nor  
10 consume any alcohol within the booth or suite that was not provided by the licensee;

11 (ii) The booth or viewing suite must be under the operational  
12 control of the licensee;

13 (iii) The licensee shall possess ultimate control of the cabinet or  
14 refrigerator inside the booth or viewing suite, and the lock of the refrigerator or cabinet shall be designed  
15 such that the key may not be removed from the refrigerator or cabinet without locking the refrigerator or  
16 cabinet;

17 (iv) The licensee shall only deliver the key to the refrigerator or  
18 cabinet to an adult utilizing the booth or viewing area; and

19 (v) The adult in receipt of the key shall not permit any minors  
20 that have access to the booth or viewing area access to the key or access to the open refrigerator or cabinet  
21 containing the alcoholic beverages.

22 (B) Delivery Restrictions. Delivery of alcoholic beverages pursuant to LVMC 6.50.095  
23 or 6.50.100(A)(1) above may only occur pursuant to the following conditions:

24 (1) [Delivery of alcoholic beverages must be in conjunction with the delivery  
25 of groceries in the same purchase order;

26 (2)] The person placing an order and the person receiving the alcoholic

1 beverages must be of legal age to purchase alcoholic beverages;

2                    [(3)] (2) Each sales transaction for delivery shall have written documentation of the  
3 sale and delivery, [on forms acceptable by the Director,] which shall include at a minimum:

4                    (a) The business name and address of the [grocery or general retail  
5 store;] selling establishment;

6                    (b) A detailed list of alcoholic beverages and [groceries] other items  
7 purchased in each sales transaction;

8                    (c) The name and address of the purchaser[;] and of the recipient;

9                    (d) The type of identification used to prove the age of the purchaser[;]  
10 and of the recipient; and

11                    (e) The signature of the delivery person [and purchaser involved in the  
12 sales transaction.];

13                    (3) If delivery of alcoholic beverages is to be accomplished by someone other  
14 than the selling establishment, the delivery service provider must hold an alcohol delivery support service  
15 alcoholic beverage license pursuant to LVMC 6.50.095 and be in compliance with that Section; and

16                    (4) Except for deliveries made directly by a grocery store with an ancillary  
17 license issued pursuant to this Section, delivery of alcoholic beverages must not be made to any parcel upon  
18 which nonrestricted gaming is conducted pursuant to or in accordance with LVMC 6.40.150.

19                    (C) Alcoholic beverages sold pursuant to this ancillary license shall be stored in such a  
20 manner that prevents public access.

21                    (D) Any ancillary license issued shall be approved on an individual basis indicating the  
22 specialty sale allowed and accounted for based upon the fees specified in LVMC 6.50.350.

23                    (E) Notwithstanding [anything] any provision of this Title to the contrary, an ancillary  
24 license is nontransferable.

25                    SECTION 3: Title 6, Chapter 50, Section 360, of the Municipal Code of the City of Las  
26 Vegas, Nevada, 1983 Edition, is hereby amended to read as follows:

1 **6.50.360:** Each licensee shall pay to the Department in advance, the semiannual license fees set forth  
 2 in the following schedule:

25 Each time-limited special event general licensee shall pay the following license fee for each day (or for each  
 26 event, in the case of a multi-day event): One hundred dollars, plus seventy-five dollars for each additional

1 bar.

2 Each time-limited special event beer/wine/cooler licensee shall pay the following license fee for each day (or  
3 for each event, in the case of a multi-day event): Fifty dollars, plus twenty-five dollars for each additional  
4 bar.

5 SECTION 4: Title 6, Chapter 50, Section 380, of the Municipal Code of the City of Las  
6 Vegas, Nevada, 1983 Edition, is hereby amended to read as follows:

7 **6.50.380:** (A) The origination charge listed in this Section is a one time charge which is due and  
8 payable at the time of filing an application for an alcoholic beverage license. Origination charges are as  
9 follows:

23 (B) The transfer of an alcoholic beverage license from one licensee to another is exempt  
24 from the origination charge set forth in this Section.

25 (C) In connection with the issuance of an original new City alcoholic beverage license  
26 to an existing County alcoholic beverage licensee whose business premises have been annexed into the City,

1 the Department shall waive the origination charge at the request of the applicant. However, a license  
2 concerning which such a waiver has been granted may not be sold, transferred to a third party, or transferred  
3 to a new location, notwithstanding any provision of this Title to the contrary.

4 SECTION 5: Title 6, Chapter 50, Section 450, of the Municipal Code of the City of Las  
5 Vegas, Nevada, 1983 Edition, is hereby amended to read as follows:

6 **6.50.450:** It is unlawful for any person to sell any alcoholic beverage:

7 (A) Without a valid unexpired license issued pursuant to this Chapter; provided,  
8 however, that this prohibition does not apply to employees of persons licensed pursuant to this Chapter during  
9 the course of such employment;

10 (B) To a person who is intoxicated;

11 (C) For delivery to a personal residence pursuant to a request for such delivery;  
12 provided, however, that this prohibition does not apply to deliveries of beer in kegs having a capacity of not  
13 less than one-quarter barrel or to deliveries authorized by LVMC 6.50.095 or 6.50.100;

14 (D) Except as otherwise specifically provided in LVMC 6.50.285, through or by means  
15 of a drive-in or walk-up window, door or other opening;

16 (E) In any manner not authorized by the license under which authority the person  
17 making such sale is authorized to do business; and

18 (F) At any place where persons under twenty-one years of age are present, unless they  
19 are continuously accompanied by a parent or legal guardian.

20 SECTION 6: Regarding any person who engages in a business within the City that  
21 facilitates the provision of alcohol delivery service but who does not engage in the actual delivery of alcohol,  
22 nothing in this Ordinance shall be deemed to:

23 (A) Require such a person to obtain a license pursuant to Section 1 of this Ordinance; or

24 (B) Eliminate, reduce or modify the requirement for such a person to obtain a business  
25 license under the appropriate licensing category.

26 SECTION 7: If any section, subsection, subdivision, paragraph, sentence, clause or phrase

1 in this ordinance or any part thereof is for any reason held to be unconstitutional or invalid or ineffective by  
2 any court of competent jurisdiction, such decision shall not affect the validity or effectiveness of the  
3 remaining portions of this ordinance or any part thereof. The City Council of the City of Las Vegas hereby  
4 declares that it would have passed each section, subsection, subdivision, paragraph, sentence, clause or phrase  
5 thereof irrespective of the fact that any one or more sections, subsections, subdivisions, paragraphs,  
6 sentences, clauses or phrases be declared unconstitutional, invalid or ineffective.

7 SECTION 8: Whenever in this ordinance any act is prohibited or is made or declared to  
8 be unlawful or an offense or a misdemeanor, or whenever in this ordinance the doing of any act is required  
9 or the failure to do any act is made or declared to be unlawful or an offense or a misdemeanor, the doing of  
10 such prohibited act or the failure to do any such required act shall constitute a misdemeanor and upon  
11 conviction thereof, shall be punished by a fine of not more than \$1,000.00 or by imprisonment for a term of  
12 not more than six months, or by any combination of such fine and imprisonment. Any day of any violation  
13 of this ordinance shall constitute a separate offense.


14 SECTION 9: All ordinances or parts of ordinances or sections, subsections, phrases,



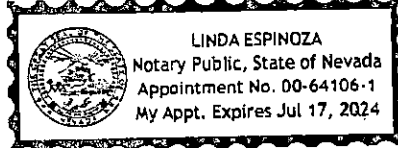
