At a regular adjourned meeting of the Board of City Commissioners of the City of Las Vegas, Clark County, Nevada, held on the 11th day of February, A.D. 1926, at the hour of three o'clock P.M. Present His Honor the Mayor, J.F.Hesse, together with Commissioners W.B.Mundy, O.J.Smith and W.H.Elwell, the City Attorney, F.A.Stevens, and the City Clerk. Commissioner Hammond being absent.

This being the time set by law for the preparation and adoption of a Budget for the year 1926 the Board thereupon proceeded to take up the budget and tax levy for the year 1926, in accordance with the provisions of the State of Nevada, and the matter being discussed at length it was ordered, upon motion being duly made by Commissioner Mundy, seconded by Commissioner Elwell, that the following Budget be adopted. Voting on said motion Commissioners Mundy, Smith and Elwell and His Honor the Mayor, J.F.Hesse, aye. Noes, none.

Whereupon the following Resolution was adopted by the Board upon motion of Commissioner Mundy, seconded by Commissioner Elwell:

BE IT RESOLVED that the said Budget be signed in behalf of this Board by the Mayor and attested by the City Clerk and the same be filed with the City Clerk and a copy thereof published in a weekly newspaper published in the City of Las Vegas, for two publications, one week

apart. The vote on said Resolution was as follows: Commissioners Kundy, Elwell and Smith and His Honor the Mayor, J.F. Hesse, Aye. Noes, none.

The Board then proceeded to take up the matter of the levy of taxes for the City of Las Vegas for the year 1926. Upon motion of Commissioner Kundy, seconded by Commissioner Smith, and unanimously carried, the following Resolution was adopted:

RESOLVED that an ad valorem tax of seven cents on each one hundred dollars worth of taxable property situate, lying and being within the City of Las Vegas, Nevada, be levied, collected and paid for the year 1926, including the net proceeds of the mines, except such property as is exempt from taxation, said tax to be known as and used as the Salary Fund.

RESOLVED that an ad valorem tax of twenty cents on each one hundred dollars worth of taxable property situate, lying and being within the City of Las Vegas, Nevada, be levied, collected and paid for the year 1926, including the net proceeds of the mines, except such property as is exempt from taxation, said tax to be known as and used as the Street Fund.

BE IT FURTHER RESOLVED that an ad valorem tax of thirteen and one half cents on each one hundred dollars worth of taxable property situate, lying and being within the City of Las Vegas, Nevada, be levied, collected and paid for the year 1926, including the net proceeds of the mines, except such property as is exempt from taxation, said tax to be known as and used as the Light Fund.

BE IT FURTHER RESOLVED that an ad valorem tax of seven cents on each one hundred dollars worth of taxable property situate, lying and being within the City of Las Vegas, Nevada, be levied, collected and paid for the year 1926, including the net proceeds of the mines, except such property as is exempt from taxation, said tax to be known as and used as the Publicity Fund.

BE IT FURTHER RESOLVED that an ad valorem tax of five and one half cents on each one hundred dollars worth of taxable property situate, lying and being within the City of Las Vegas, Nevada, be levied, collected and paid for the year 1926, including the net proceeds of the mines, except such property as is exempt from taxation, said tax to be known as and used as the Emergency Loan Fund.

BE IT FURTHER RESOLVED that an ad valorem tax of four and one half cents on each one hundred dollars worth of taxable property, situate, lying and being within the City of Las Vegas, Nevada, be levied, collected and paid for the year 1926, including the net proceeds of the mines, except such property as is exempt from taxation, said tax to be known as and used as the Sewer Bond Interest Fund.

BE IT FURTHER RESOLVED that an ad valorem tax of fourteen cents on each one hundred dollars worth of taxable property situate, lying and being within the City of Las Vegas, Nevada, be levied, collected and paid for the year 1926, including the net proceeds of the mines, except such property as is exempt from taxation, said tax to be known as and used as the Sewer Bond Redemption Fund.

BE IT FURTHER RESOLVED that an ad valorem tax of nine cents on each one hundred dollars worth of taxable property situate, lying and being within the City of Las Vegas, Nevada, be levied, collected and paid for the year 1926, including the net proceeds of the mines, except such property as is exempt from taxation, said tax to be known as and used as the Highway Bond Interest Fund.

BE IT FURTHER RESOLVED that an ad valorem tax of seven and one half cents on each one hundred dollars worth of taxable property situate, lying and being within the City of Las Vegas, be levied, collected and paid for the year 1926, including the net proceeds of the mines for the year 1926, said tax to be known as and used as the Highway Bond Redemption Fund.

The vote on said Resolution was as follows: Commissioners Kundy, Smith, Elwell and His Honor the Mayor, J.F. Hesse, Aye. Noes, none.

The following Resolution was adopted upon motion of Commissioner Mundy, seconded by Commissioner Smith;

RESOLVED that the City Clerk be and she is hereby authorized and directed to notify the board of County Commissioners of Clark County, Nevada, of the tax rate established and levied by this Board for the year 1926, and to direct said Board of County Commissioners to levy and cause to be collected and paid the sum of eighty-eight cents on each one hundred dollars worth of taxable property situate, lying and being within the City of Las Vegas, Nevada, including the net proceeds of the mines for the year 1926, except such property as is exempt from taxation, said tax to be known as and used as the City of Las Vegas Fund. Voting on said Resolution Commissioners Mundy, Smith, Elwell and His Honor the Mayor, J.F.Hesse, Aye. Noes, none.

There being no further business to come before the Board at this time, it was ordered, on motion duly made and carried that the Board adjourn until Friday the 12th day of February, A.D. 1926, at the hour of three o'clock P.M. Voting on said motion, Commissioners Mundy, Smith, Elwell and His Honor the Mayor, J.F.Hesse, Aye. Noes, none.
