At a regular adjourned meeting of the Board of City Commissioners of the City of Las Vegas, Clark County, Nevada, held on the 8th day of September, A.D. 1926, at the hour of three o'clock P.M. Present His Honor the Mayor J.F. Hesse, with Commissioners W.B. Mundy, O.J. Smith and W.H. Elwell, together with the City Attorney and the City Clerk, Commissioner C.J. Hammond being absent.

At this time on request of the Mayor, Mayor Pro Tem W.B. Mundy took the chair.

Whereupon the plat of the proposed Boulder addition to the City of Las Vegas was presented to the Board for approval, whereupon, it was ordered, upon motion of Commissioner Elwell, seconded by Commissioner Smith, that said plat of Boulder Addition to the City of Las Vegas be and the same is hereby accepted, and the Mayor Pro Tem is hereby ordered to approve the same, and his signature to be attest by the City Clerk; it was further ordered that the extension of Main Street as it now exists over said land be vacated, provided however, that said vacation shall not be effective until a road along Main Street of said Boulder Addition as designated on the said plat has been constructed and placed in as good condition as the road that is hereby vacated. Voting on said motion Commissioners Smith, Elwell and Mayor Pro Tem Mundy, Aye. Hoes, none. Mayor J.F. Hesse not voting.

Thereupon, there being no further business to come before the Board at this time, it is ordered that the Board adjourn until the next regular meeting to be held on Thursday, the 7th day of October, A.D. 1926, at the hour of three o'clock P.M.

At a regular meeting of the Board of City Commissioners of the City of Las Vegas, Clark County Nevada, held on the 7th day of October, A.D. 1926, at the hour of three o'clock P.M. Present Hon. J.F. Hesse, Mayor, with Commissioners O.J. Smith and W.H. Elwell, together with the City Attorney and City Clerk, Commissioners C.J. Hammond and W.B. Mundy being absent.

The minutes of the previous meeting were read, and there being no omissions or corrections, were approved as read.

Reports of officers were read, approved and ordered placed on file in the office of the Clerk. All claims allowed as per claim book on file in the office of the Clerk.

At this time Leo A. McNamee Esq., appeared before the Board and presented the following communication:

Dear Sirs:

The undersigned, Hawkins Land and Water Company, a corporation respectfully petitions your Honorable Board for a permit to use certain of the Streets and Alleys of the City of Las Vegas, Clark County, Nevada, for the purpose of laying water mains to supply the inhabitants of South Addition to the City of Las Vegas with Water.

The undersigned has entered into a contract with the Las Vegas Land and Water Company, whereby said Company agrees to furnish the undersigned with water.

The Streets and alleys desired to be used under said requested permit are as follows, to-wit:

Beginning at the Southerly end of the alley in Block 8 of Clark's Las Vegas Townsite, thence Southerly across Garces Street at right angle, thence along the alley in Block 1 of South Addition, thence along the Easterly side of Main Street, as designated, on the plat of South Addition, to Charleston Boulevard to the Southerly end of the alley in Block 10, South Addition, thence Northerly along the alley in Blocks 10, 9, 8, 7, 6, in said South Addition to Garces Street crossing Boulder, Coolidge, Hoover and Cass Streets, respectively, thence across Garces Street to the Alley in Block 9 of Clark's Las Vegas Townsite.

Also beginning at the Southerly end of the alley in Block 24 of Clark's Las Vegas Townsite, thence Southerly across Garces Street at right angle, thence Southerly along the alleys in Blocks 11, 12, 13 and 14, South Addition to Charleston Boulevard, crossing Cass, Hoover and Coolidge Streets respectively, thence East along the Northerly side of Charleston Boulevard to the Southerly end of the alley in Block 18 South Addition, thence Northerly along the alley in Blocks 18, 17, 16, 15 to Garces Street crossing Coolidge, Hoover and Cass Streets respectively, thence across Garces Street to the Southerly end of the alley in Block 25 of Clark's Las Vegas Townsite.

Also beginning at the Southerly end of the alley in Block 40 of Clark's Las Vegas Townsite thence across Garces street at right angles, thence Southerly along the alley in Blocks 19, 20, 21 South Addition to Coolidge St. crossing Cass and Hoover Streets respectively, thence Easterly along Coolidge Street to its intersection with Charleston Boulevard, thence easterly along Charleston Boulevard across Fifth Street to the Southerly end of the Alley in Block 27, South Addition; thence Northerly along the alley in Blocks 27, 26, 25, 24 and 23, South Addition to Clark Street crossing Hoover, Cass, Garces and Bonneville Streets respectively.

Also beginning at the northerly end of the alley in Block 19, South Addition, thence easterly along the Southerly side of Garces Street to the Northerly end of the alley in Block 33, South Addition (the same being Block 12, Wardie Addition) crossing Fifth, Sixth and Seventh Streets.

Also beginning at the Northerly end of the alley in Block 30, South Addition, thence Northerly across Garces Street to the Alley in Block 29, South Addition, thence Northerly along the alley in said Block 29 to Bonneville Street.

Also beginning at the Northerly end of the alley in Block 30, South Addition, thence Southerly along the alley in Blocks 30 and 31 to Hoover Street crossing Cass Street; thence Easterly along Hoover Street crossing Seventh Street to Charleston Boulevard; thence Easterly along the Northerly side of Charleston Boulevard to the alley in Block 34, South Addition; thence Northerly along the alley in said Block 34 and along the alley in Block 33, South Addition (Block 12, Wardie Addition) to Garces Street crossing Cass street.

Also beginning at the Southerly end of the alley in Block 31, thence across Hoover Street to Block 32.

That the undersigned intends to lay a six inch water main from the Southerly end of the alley in Block 8, Clark's Las Vegas Townsite along the alley in Block 1 and along the easterly side of Main Street to Charleston Boulevard; and also a six inch water main from the northerly end of the alley in Block 19, South Addition along the southerly side of Garces street to the northerly end of the alley in Block 33 South Addition and all of the rest of said water mains shall be four inches.

The undersigned will also file with the Public Service Commission of the State of Nevada, a schedule of its rates and charges for water service and shall also file what ever rules and regulations it may promulgate and shall also apply to said Public Service Commission for a certificate of Public Convenience and shall in all respects comply with the statutes of the State of Nevada, and with the rules, regulations and orders of the Public Service Commission of the State of Nevada, relative to furnishing water to said South Addition as a public utility.

Voting on said motion Commissioners Smith, Elwell, and His Honor the Mayor, J.F.Hesse, Aye. Noes, none.

On motion of Commissioner Smith, seconded by Commissioner Elwell, it was ordered that there be no further business to come before the Board at this time, it was ordered, the license and fines for the month of September, 1926, be distributed as follows: on motion duly made and carried, that the Board adjourn until Friday, the 8th day of October, A.D. 1926, at the hour of three o'clock P.M. Voting on said motion Commissioners Smith, Elwell and His Honor the Mayor, J.F.Hesse, Aye. Noes, none.

Whereupon the Clerk presented the application of Morgan, Stocker and Horden for a gaming license for three games at the Vegas Bar on Fremont Street, the same having been theretofore approved by Police and Fire Commissioner C.J.Hammond, whereupon an order was made upon motion of Commissioner Elwell, seconded by Commissioner Smith, directing the Clerk to issue a license for three games to Morgan, Stocker and Horden at the Vegas Bar. Voting on said motion Commissioners Smith, Elwell, and Mayor Hesse, Aye. Noes, None.

The Clerk then presented the application of A.T.McCarter for a gaming license for three games at the Exchange Pool Hall on First Street, the same having been theretofore approved by Police and Fire Commissioner Hammond, whereupon an order was made upon motion of Commissioner Elwell, seconded by Commissioner Smith, directing the Clerk to issue license for three games to A.T.McCarter at the Exchange Pool Hall on First Street. Voting on said motion Commissioners Smith, Elwell, and His Honor the Mayor, J.F.Hesse, Aye. Noes, none.

Whereupon the Clerk presented the application of G.Lopez for a gaming license for two games at the Miners Club on North First Street, the same having been theretofore approved by Police and Fire Commissioner Hammond, whereupon an order was made upon motion of Commissioner Smith, seconded by Commissioner Elwell, directing the Clerk to issue a license for two games to G.Lopez at the Miners Club on North First Street. Voting on said motion Commissioners Smith, Elwell and His Honor the Mayor, J.F.Hesse, Aye. Noes, none.

There being no further business to come before the Board, an order was made upon motion of Commissioner Smith, seconded by Commissioner Elwell, that the Board adjourn until the next regular meeting to be held on the 4th day of November, A.D. 1926, at the hour of three o'clock P.M. Voting on said motion Commissioners Commissioners Smith, Elwell, and His Honor the Mayor, J.F.Hesse, voting aye. Noes, none.
