It appearing to the Board that the various tourists camps in this City are privately owned and that they have a legal right to accommodate or reject any persons, it was ordered upon motion duly made, seconded and carried that this matter be referred back to the Chamber of Commerce and that the Clerk be directed to write to the said Chamber of Commerce and state that this Board has no power to regulate tourists camp grounds in this regard and that it is the opinion of this Board that this matter can be better handled by the Chamber of Commerce.

No further business appearing it was ordered upon motion duly made that this meeting adjourn until October 18th, 1927, at the hour of three o'clock P. M.

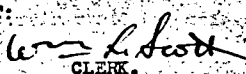

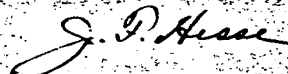
