Present: His Honor the Mayor, J. F. Hesse; Commissioners W. B. Mundy, O. J. Smith, W. C. German, and Roy Neagle, together with the City Attorney and Clerk.

Meeting called to order by the Mayor.

After full discussion as to the advisability of purchasing a new fire alarm siren, it was moved by Commissioner Smith, seconded by Commissioner German that a contract be entered into by the City and Bletzacker for the purchase by the City of a fire alarm system in accordance with the proposal heretofore submitted to this Board by said Bletzacker and Bletzacker. That such contract be executed by the Mayor, Police & Fire Commissioner and attested by the City Clerk, That said contract be such terms and conditions as the Mayor and Police & Fire Commissioner shall prescribe and that the purchase price shall not exceed the sum of Six hundred seventy-three (\$673.35) Dollars and thirty-five cents, as mentioned in such proposal.

Vote on said motion was as follows: Commissioners, Mundy, German, Neagle, Smith, and His Honor the Mayor, J. F. Hesse voting aye. Noes, none.

Thereafter the Board discussed various phases of the proposed paving of the City Streets.
