Proposed ordinance No. _____, entitled, "An Ordinance to Amend, Revise and re-enact Section 22 of Ordinance No. 66 of the City of Las Vegas, entitled: "An Ordinance regulating travel and traffic upon the public streets of the City of Las Vegas, Nevada," and further amending said Ordinance by adding thereto two sections to be known as Sections 21a and 21b, respectively, and to repeal all ordinances and parts of Ordinances in conflict therewith", was read for the first time and laid over for second reading.

Proposed ordinance No. _____, entitled, "An Ordinance providing for the licensing of electrical workers in the City of Las Vegas, and fixing a penalty for the violation thereof", was read for the first time and laid over for second reading.

Upon motion duly made, seconded and carried, it was ordered that the sum of \$1500.00 be paid on the Emergency Loan Note of 1925, held by the First State Bank, together with interest accrued thereon; and that the City Treasurer be directed to make this payment and that the City Clerk be authorized and directed to issue his warrant in the amount of \$1532.00, to cover said payment.

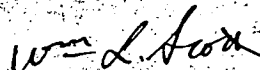
Meeting called to order by the Mayor.
