Minutes of meeting of October 14th, 18th, 19th 31st and November 5th read and approved as read.

Reports of Municipal Judge, Chief of Police, Building Inspector, Plumbing Inspector, Electrical Inspector and Clerk were presented to the Board, and approved.

An Ordinance to amend Ordinance No. 144 of the City of Las Vegas, entitled, "An Ordinance of the City of Las Vegas Regulating the Erection, Construction, Enlargement, Alteration, Repair, Moving, Removal, Demolition, Conversion, Occupancy, Equipment, Use, Height, Area, Maintenance, Of All Buildings And /Or Structures in the City of Las Vegas; Providing for the issuance of Permits, and Collection of Fees Therefor; Providing Penalties For teh Violation thereof; Declaring And Establishing Fire Zones; Repealing Ordinances Nos. Twenty-seven (27) Fifty-Nine (59) Sixty-one (61) and Seventy-two (72) of the City of Las Vegas, and all other Ordinances, and parts of In Conflict Therewith," approved August 1st 1929, by adding thereto a new Section to be known as Section 4a, was read to the Board for a first time.

An Ordinance declaring the determination of the Board of Commissioners of the City of Las Vegas to make certain improvements in the City of Las Vegas by grading for and constructing Asphaltic Concrete Pavement-Durite Process on certain streets, and portions of streets in the City; describing definitely the location of said improvements; providing that the cost, and expense thereof shall be paid entirely by special assessment upon all the lots included in the special assessment district, hereby established, according to benefits, except where, by the Charter of the City of Las Vegas certain portions thereof are required to be paid from the general fund of said City of Las Vegas; providing for the issuance of special assessment bonds and also general bonds of the City of Las Vegas for the payment thereof and other matters relating thereto. was read to the Board for a first time.

An Ordinance declaring the determination of the Board of Commissioners of the City of Las Vegas to make certain improvements in the City of Las Vegas by grading for, and constructing Hydralis Cement Concrete Curb and Gutter and Rough Grading for Street Improvement on certain streets and portions of streets in said City; describing definitely the location of said improvements; providing that the cost and expense thereof shall be paid entirely by special assessment upon all the lots included in said special assessment district, hereby established, according to benefits, except where, by the Charter of the City of Las Vegas certain portions thereof are required to be paid from the general fund of said City of Las Vegas; providing for the issuance of special assessment bonds and also general bonds of the City of Las Vegas for the payment thereof and other matters relating thereto, was read to the Board for a first time.

An Ordinance empowering, authorizing and directing the ex-officio Assessor of the City of Las Vegas, County of Clark, State of Nevada, to levy a special assessment to defray the costs of making certain improvements in the City of Las Vegas, by constructing, erecting, and installing an ornamental street lighting system complete, including conduits, cables, standards, lighting units and all appurtenances thereto on certain streets, and portions of streets in said city according to plats, diagrams, and estimates of cost thereof on file in the office of the City Clerk of the City of Las Vegas; describing definitely the location of said improvements, stating the amounts of said assessment, and designating the lots, lands, and premises to be assessed according to benefits; providing for the payment thereof, and other matters relating thereto", was read to the Board for a second time, and passed by the following vote.; Commissioners Thomas German, and Smith, and His Honor the Mayor voting Aye. Noes None. Same was ordered published for one week (three issues) in the Las Vegas Age, a tri-weekly newspaper published in the City of Las Vegas.

To the Honorable Board of City Commissioners:

We the undersigned property holders on Fremont Street most respectfully petition your Board to at this time make provision for the widening of Fremont Street by setting the curbs on both sides of the street back three feet(3'). The present installation of street lights should be made to conform with this programme. It is understood that the base of the light will be not over 10' from the face of the curb.

Said Petition being signed by 39 property owners. The Clerk was directed to check the petition to see that the names of the 38 property owners represented 51% of the property to be improved.

The audit of the books of the City as made by W. J. Hooper was read to the Board, and ordered placed on file. The Clerk was directed to write the Municipal Judge, and the President of the Cemetery Board asking each to turn all monies over to the City Clerk hereafter and noting the City Treasurer has has been done in the past.

At a recessed regular meeting of the Board of City Commissioners of the City of Las Vegas, Nevada, held on the 12th day of November 1929 at the hour of three o'clock P.M.

Present Mayor J. F. Hesse, Commissioners Hansell, Smith, and German together with the City Attorney and Clerk.

Minutes of meetings of November 7th, 8th and 9th 1929, read, and approved as read.

The following Resolution from the Las Vegas Chamber of Commerce was read to the Board.

- WHEREAS, Motor traffic on the Arrowhead Trail (U. S. 91) between Southern California and Las Vegas is steadily increasing in volume, and
- WHEREAS, The importance of said section of said highway is evidenced by the fact that the State of California has voted an expenditure in excess of two million three hundred thousand dollars for the improvement and reconstruction of said highway between Barstow, California, and the California-Nevada State line, and
- WHEREAS, The matter of good roads between Las Vegas, Nevada, and Southern California is of greater importance to the Southern part of Nevada at this time than to elsewhere, and
- WHEREAS, That section of said highway extending from Jean, Nevada, to the California-Nevada line, an approximate distance of fourteen miles, is in poor repair, NOW THEREFORE BE IT
- RESOLVED; That the Las Vegas, Nevada Chamber of Commerce, in regular meeting assembled this fifth day of November 1929, urge the Nevada State Department of Highways, to immediately direct their activities toward the improvement of that section of the Arrowhead Trail (U. S. 91) extending from the end of the improved highway at or near Jean, Nevada, to the California-Nevada State line, and to connect with said highway at said State line, and BE IT FURTHER
- RESOLVED: That a copy of this resolution be forwarded to the Las Vegas City Commissioners, the local office of the State Highway Department and to the State Highway Department Headquarters, Carson City, Nevada.
