At a recessed regular meeting of the Board of Commissioners of the City of Las Vegas held on the 15th day of October, 1930 at the hour of three o'clock P.M.

Present Mayor Hesse, Commissioners Smith, Thomas, and Hansell together with the City Attorney and Clerk.

Absent Commissioner German.

Minutes of previous meetings read and approved as read.

A petition was filed with the Board of Commissioners signed by a number of citizens asking that Henry Blackall be placed on the Police Department and patrol the northern portion of the City. Said petition was referred to R. W. Thomas Police and Fire Commissioner for his consideration.

A letter from the Deer Creek Corporation was read to the Board asking that the City help construct six miles of road into Deer Creek, and that the Deer Creek Corporation would deed to the City and County of Clark 20 acres of land to be used as a public park.

City Attorney Stevens informed the Board that the City could not acquire lands out side of the city limits except for water right. Clerk was directed to write to said corporation and thank them for their offer, and explain to them the reason for not accepting their offer.

Upon motion of Commissioner Smith seconded by Commissioner Hansell it was moved that the following gaming application be granted, said applications being accompanied by money covering the amount of tables applied for:

Mayne W. Stocker, four tables, application accompanied by \$350.00

Leo Kind, two tables, application being accompanied by \$150.00

A. T. Mc Carter, three tables, application being accompanied by \$250.00

H.P. Harris and Lyle Smith, two tables, \$150.00 accompanying application.

Geo. Smith, and Jack Butler, two tables, application being accompanied by \$150.00

The foregoing applications being approved by R. W. Thomas, Police & Fire Commissioner.

Vote on said motion being as follows: Commissioners Smith, Thomas, and Hansell, and His Honor the Mayor voting Aye. Noes none.

The applications of Boulder Club, Las Vegas Club, and Chas. Taylor Company being held over until the application are properly filled out.

The application of Cleto Aguirre was laid over for further investigation.

Upon motion of Commissioner Hansell, seconded by Commissioner Smith it was moved that the gaming applications of Don Yee, and W. Peccetti not be granted as same were not approved by the Police and Fire Commissioner Thomas.

Vote on said motion was as follows: Commissioners Smith, Thomas, and Hansell, and His Honor the Mayor voting Aye. Noes none.

The Board next considered a letter from the Board of Examination of the Civil Engineers and Surveyors offering their services gratis in drafting an ordinance for the joining of the City of Las Vegas to the Board of Commissioners should consider such an ordinance at this time.

The Clerk was directed to send the Board of Examination of Civil Engineers and Surveyor a copy of the "Zoning Ordinance," that the Board of Commissioners has considered some time ago.

The apportionment of the unpaid assessments of lots owned by Carrie L. Blood, and Helen C. Armistead as prepared by Ex-Officio Assessor Devinney was next considered. The following proportioning being considered.

Armistead, agreed to assume 67/100ths of said assessments, and

It appearing by such Resolution that said Carrie L. Blood, a widow, still owns the westerly sixty-seven (67) feet of said lots, and Helen C. Armistead, a widow, owns the easterly sixty-seven (67) feet thereof, and

By such Resolution I was required to report such apportionment as made by me back to this Board for confirmation,

At a recessed regular meeting of the Board of Commissioners of the City of Las Vegas, Nevada, held on the 23rd day of October, 1930, at the hour of three o'clock P.M.

Present Mayor Hesse, Commissioners Hansell, Smith, and Thomas, together with the City Attorney, and Clerk.

Absent Commissioner German.

Minutes of meeting of October 15th read and approved as read.

The bill of Dr. M. Michelena for \$35.00 for care of City prisoner was allowed same being approved by Police & Fire Commissioner, and O.J. Smith acting Finance Commissioner, and approved by Mayor Hesse, for \$35.00.

The gaming application of Las Vegas Club was next brought before the Board, and upon motion of Commissioner Hansell, seconded by Commissioner Smith a license for the operation of two gaming tables was granted. Said application being accompanied by \$150.00. Vote on said motion was as follows, Commissioners Smith, Thomas, and Hansell, and His Honor the Mayor voting Aye. Noes none.

The gaming application of Boulder Club for the operation of three tables with \$250.00 accompanying said application was next brought before the Board. Upon motion of Commissioner Hansell seconded by Commissioner Smith it was moved that the license be granted.

Vote on said motion was as follows: Commissioners Smith, Thomas, and Hansell, and His Honor the Mayor voting Aye. Noes none.

The gaming application of J. R. Boyer for the operation of two gaming tables, and the sum of \$150.00 covering same having been deposited with the City Clerk was next considered, and upon motion of Commissioner Hansell seconded by Commissioner Smith it was moved that said license be granted.

Vote on said motion was as follows: Commissioners Smith, Hansell, and Thomas, and His Honor the Mayor voting Aye. Noes none.

The application of the Chas. Taylor company was next considered. Said application being accompanied by a check for \$150.00 signed by one Henry Wong, for the operation of two tables. Names of member of said Chas. Taylor Co; and the name of the manager being on said application. After a lengthy discussion upon motion of Commissioner Hansell, seconded by Mayor Hesse it was moved that the license be granted.

Vote on said motion was as follows: Commissioners Smith, and Hansell, and His Honor the Mayor voting Aye. and Commissioner Thomas voting No.

Mr. John Miller appeared before the Board at this time asking that the Board of Commissioners again consider the widening of Fremont Street from Main Street to Second Street. After some discussion by the Board the following Resolution was duly adopted:

Resolved, that the City Planning Commission investigate the widening of Fremont Street from Main to Second St, and present a written report to the Board for their consideration at a meeting of the Board of Commissioners to be held on the 31st day of October at the hour of three o'clock P.M.
