At a recessed regular meeting of the Board of Commissioners held on the 25th day of March 1931 at the hour of three o'clock P.M.

Present Mayor Hesse, Commissioners Thomas, Hansell and Smith together with the City Attorney and Clerk.

Absent Commissioner German.

At this time and Ordinance entitled, "An Ordinance regulating dry cleaning plants in the City of Las Vegas, providing penalties for the violation thereof, and other matters relating thereto, and repealing all ordinances, and parts of ordinances in conflict therewith," was read for the first time and laid over for a second reading.

An Ordinance entitled, "An Ordinance Regulating the Construction and Maintenance of Garages, Filling Stations, and the Storage of Gasoline and other Inflammable Liquids and High Explosives Within the City of Las Vegas, and Repealing all Ordinances and parts of Ordinances in Conflict Therewith," was read for a first time and laid over for a second reading.

An Ordinance entitled, "An Ordinance of the City of Las Vegas regulating the Erection, Construction, Enlargement, Alteration, Repair, Moving, Removal, Demolition, Conversion, Occupancy, Equipment, Use High, Area, and Maintenance, of all buildings and/or structures in the City of Las Vegas; providing for the issuance of Permits, and collection thereof; declaring and establishing Fire Zones; Repealing Ordinances Nos. 144-27-59-61-72 of the City of Las Vegas and all other Ordinances and parts of Ordinances in conflict therewith," was read for a first time and laid over for a second reading.

The resignation of the Deputy City Attorney Dan V. Noland was presented to the Board for its consideration.

Upon motion of Commissioner Smith, seconded by Commissioner Hansell the following resolution was adopted:

Whereas Dan V. Noland, Deputy City Attorney for the City of Las Vegas, Nevada, has voluntarily tendered his resignation as such officer and has requested the immediate acceptance thereof,

Now Therefore Be It Resolved that the resignation of Mr. Noland be and the same is hereby accepted, and his bondsmen are hereby relieved from further obligation on account of the bond of said Deputy City Attorney.

Vote on said Resolution was as follows: Commissioners Hansell, Thomas, and Smith and His Honor the Mayor voting Aye. Nones None.

At this time the Board took up the matter of the City license on gaming tables in the City of Las Vegas. No decision was reached at this time.

No further business appearing before the Board at this time the meeting recessed until Thursday the 26th day of March 1931 at the hour of three o'clock P.M.

At a recessed regular meeting of the Board of Commissioners of the City of Las Vegas, held on the 26th day of March 1931 at the hour of three o'clock P.M.

Present Mayor Hesse, Commissioners Hansell, Thomas, Smith and German, together with the City Attorney and Clerk.

The plat of Williams Addition was presented to the Board for its approval. Same being approved by the City Planning Commission.

Upon motion of Commissioner Smith seconded by Commissioner Thomas it was moved that the Plat of Williams Addition be approved, that same be signed by the Mayor, and attest by the City Clerk under the Seal of the City.

Vote on said motion was as follows: Commissioners Thomas, Hansell, German, and Smith and His Honor the Mayor J. P. Hesse, voting Aye. Nones none.

The Plat of the the Rose Garden Addition was presented to the Board for its approval. same being approved by the City Planning Commission.

Upon motion of Commissioner Smith seconded by Commissioner Hansell it was moved that said Plat be approved, and that same be signed by the Mayor and attest by the City Clerk under the Seal of the City of Las Vegas.

Vote on said motion was as follows: Commissioners Thomas, Hansell, German, and Smith and His Honor the Mayor voting Aye. Nones none.

The matter of providing for a drainage system for the southwest part of the City was next brought before the Board for consideration. City Engineer Thompson was directed to look into the matter and see what type of system could best be used in caring for the flood waters during the rainy seasons.

The Board again considered that matter of setting the license on gaming tables for the City of Las Vegas, but no decision was reached at this time.

No further business appearing before the Board at this time the meeting recessed until Saturday the 28 day of March 1931 at the hour of three o'clock P.M.

At a recessed regular meeting of the Board of Commissioners of the City of Las Vegas held on the 30th day of March 1931, at the hour of three o'clock P.M.

Present Mayor Hesse, Commissioners Thomas German Hansell and Smith together with the City Attorney and Clerk.

At this time the Board took up the matter of removing the "Welcoming Arch across Fremont Street at Main Street as said arch was becoming a menace to the public. Upon motion of Commissioner Thomas Seconded by Commissioner German the following Resolution was duly passed:

Resolved, That the Commissioner of Streets and Public Places be and he is hereby authorized to have taken down the arch across Fremont Street at its intersection with Main Street on such terms as he may deem advisable.

The vote on said Resolution was as follows: Commissioners German, Hansell, Thomas and Smith and His Honor the Mayor voting Aye. Noes none.

At this time the Board took up the matter of the passing of a new gaming Ordinance and discussed the various ways in which the licenses might be granted. After some discussion upon motion of Commissioner Thomas seconded by Commissioner Hansell it was moved that the Board not grant gaming licenses unless the full Board was present and said motion would have the full vote of the Board. The vote on said motion was as follows: Commissioners Thomas and Hansell voting Aye. Commissioners German, and Smith and His Honor the Mayor voting NO.

At this time the matter of passing a gaming ordinance was brought before the Board for its consideration.

Upon motion of Commissioner Smith seconded By Commissioner Thomas the following Resolution was passed and duly adopted:

Resolved, That an Ordinance entitled, "An Ordinance to prohibit gaming and operation of slot machines in the City of Las Vegas, without first obtaining a license therefor regulating the same, fixing the amount of such license, providing a penalty therefor, repealing Ordinances Nos. 77, 82, 88, 103, and 115 and all ordinances and parts of ordinances in conflict therewith," be passed at this meeting as an emergency ordinance deeming that an emergency exists for the collection of fees hereunder for the benefit of the City.

Vote on said Resolution was as follows: Commissioners Thomas, German, Hansell, and Smith and His Honor the Mayor voting Aye. Noes none.

Thereupon motion of Commissioner Thomas, seconded by Commissioners German it was moved that an ordinance entitled, "An Ordinance to prohibit gaming and operation of slot machines in the City of Las Vegas, without first obtaining a license therefor, regulating the same, fixing the amount of such licenses, providing a penalty therefor, repealing Ordinances Nos. 77, 82, 88, 103, and 115, and all Ordinances and parts of Ordinances in conflict therewith," be read for the first and second times at this meeting and passed as an emergency ordinance.

Vote on said motion was as follows: Commissioners German, Smith, Thomas, and Hansell, and His Honor the Mayor voting Aye. Noes none.

There upon the above mentioned Ordinance was read for a first and second time, and passed as an emergency ordinance by the following vote, Commissioners Thomas, Smith, German, and Hansell voting Aye. Noes none.

The Clerk was directed to have said Ordinance published in the Las Vegas Age, a tri-weekly newspaper printed and published in the City of Las Vegas, for three issues, one week, and that said Ordinance be in full force and effect from and after its complete publication.

No further business appearing before the Board at this time the meeting adjourned.
