At a recessed regular meeting of the Board of Commissioners of the City of Las Vegas held on the 8th day of May at the hour of eight o'clock P.M.

Present Mayor Hesse, Commissioners German, Thomas and Hansell together with the City Attorney and Clerk.

Absent Commissioner Smith.

At this time the Board of Commissioners entered into a discussion as to the way to handle the case filed in Carson City in the Supreme Court by Attorney Morsey, for Roy Grimes. Said suit was filed because the Board of City Commissioners refused to grant a gaming license to said Roy Grimes and partners to be operated under at Lorenzi Resort.

After some discussion upon motion of Commissioner Thomas, seconded by Commissioner German the following resolution was duly passed:

Resolved, That F. A. Stevens, City Attorney of the City of Las Vegas, be directed to appear in Carson City, Nevada, on May 27th, 1931, and file a demure in answer to the suit filed in the Supreme Court in said Carson City against the City of Las Vegas, naming the Board of City Commissioners, The Mayor of the City of Las Vegas, and each individual Commissioner. That the City of Las Vegas bear the expense of the said City Attorney's trip in representing the City Board of Commissioners, the Mayor and each individual Commissioner.

Vote on said Resolution was as follows: Commissioners German, and Thomas, and His Honor the Mayor voting Aye. Commissioner Hansell voting No.
