Roll call showed the following present Mayor Arnett, Commissioners Krause, Marble and Ronnow City Attorney and City Clerk.

Absent Commissioner Perry.

Minutes of all regular, special and recessed meetings read and approved as read.

On motion of Commissioner Marble seconded by Commissioner Krause it was moved and carried that permission be granted the Grand Canyon Airlines to operate a taxi from the Sal Sage Hotel. Said permission to be granted only upon receipt by the Clerk of the written approval of the allowing of this permit by John Miller Owner of the Sal Sage Hotel.

Vote Commissioners Krause, Marble and Ronnow and His Honor the Mayor voting aye. Noes, none

On motion of Commissioner Krause seconded by Commissioner Marble it was moved that tavern licenses for the year 1938 be granted to the following applicants:

On motion of Commissioner Ronnow the following licenses for the year 1938 were granted National Ice Company and Atlas Supply Co. for wholesale beverages

A.T. Spatz, Geo Markisch and Morris Rose retail sealed package liquor.

Vote Commissioners Krause Marble and Ronnow and His Honor the Mayor voting aye. Noes, none

All the above applications were granted only with the approval of the Chief of Police David Mackey.

On motion of Commissioner Marble seconded by Ronnow it was moved and carried that W.J. Flowers, operator of the Las Vegas Credit Bureau pay a license of \$5.00 per calendar quarter if he would file in the office of the Clerk a written statement that his collection department operated in connection with the Credit Bureau amounted to 25% or less than his total business.

Vote Commissioners Krause, Marble, and Ronnow/voting aye. Noes, none.

On of Commissioner Krause seconded by Commissioner Ronnow it was moved and carried that the following persons be granted gambling and slot machine licenses:

The following entitled Ordinance was read to the Board for a first time: AN ORDINANCE TO AMEND SECTION 2 AND SECTION 3 AS AMENDED, OF ORDINANCE NO. 168 OF THE CITY OF LAS VEGAS, ENTITLED: "AN ORDINANCE OF THE COMMISSION OF THE CITY OF LAS VEGAS, ESTABLISHING A RESIDENCE DISTRICT, INDUSTRIAL AND COMMERCIAL DISTRICTS WITHIN THE SAID CITY OF LAS VEGAS; DEFINING SUCH DISTRICTS; DECLARING IT UNLAWFUL TO ERECT, ESTABLISH, MAINTAIN, OR OPERATE CERTAIN FACTORIES, WORKS, OR ESTABLISHMENTS WITHIN SAID RESIDENTIAL DISTRICTS AND SAID COMMERCIAL DISTRICTS; REGULATING THE ERECTION, ESTABLISHMENT, MAINTENANCE, OPERATION AND REBUILDING OF CERTAIN WORKS OR ESTABLISHMENTS IN SAID DISTRICTS; PROVIDING PENALTIES FOR THE VIOLATION OF SAID ORDINANCE, AND REPEALING ORDINANCES IN CONFLICT HERWITH," and vote upon the adoption of said Ordinance was Commissioners Krause, Marble, Ronnow and His Honor the Mayor. Noes, none, absent Commissioner Perry.

Said Ordinance to be known as Ordinance No. 229, and the Clerk was directed to forthwith have same published in the Las Vegas Age, a weekly newspaper published in the City of Las Vegas, for once a week for two consecutive weeks.

No further business appearing before the Board at this time the meeting adjourned.

Minutes of a regular meeting of the Board of Commissioners of the City of Las Vegas held on the 4th day of January, 1938 at the hour of seven o'clock P.M.

Roll call showed the following present Mayor Arnett, Commissioners Krause, Marble and Perry, City Attorney and City Clerk.

Absent Commissioner Ronnow.

All claims allowed as per "Claims & Warrant Register" on file in the office of the Clerk.

At this time Commissioner Marble ask to be excused.

Members of the Recreational Board were present at this time and presented its plans for the year 1938 to the Board. Among the plans was the purchase of approximately one city block of unimproved ground to be used as a play or recreational ground near the Westside Grammar School.

On motion of Commissioner Krause seconded by Commissioner Perry it was moved and carried that the Recreational Board find a suitable site for a playground costing approximately 0 ne hundred dollars and negotiated for the purchase of the same.

Vote was Commissioners Krause, Perry and His Honor the Mayor voting eye. Noes, none. Commissioner Marble excused and Commissioner Bonnow absent. Noes, none.

Mrs. Jondahl appeared before the Board and reported on the treatment of animals at the City Pound and their disposal as same had been brought to her attention. Mrs. Jondahl also informed the Board that at one time two officers of the City Police Department shot a dog under the porch of a house at the S.W. cor of Carson & Fifth streets. Same occurring during the day, and a tourist passing picked up the dog and after wrapping his leg took him away in a car. The Board was also informed that Reynolds Putnam had remarked to Mrs. Jondahl of the very inhuman treatment received by animals from the Poundmaster and had informed people to dispose of their own animals rather than have them sent to the pound.

Mrs. Jondahl was told that the Board would take immediate steps to investigate this matter and if animals were not treated in a human manner this practise would be stopped at once.

Bids for the purchase of gasoline for the City for the year 1938 were opened and upon motion of Commissioner Perry seconded by Commissioner Krause it was moved and carried that the City enter into agreement with all oil companies bidding \$.1625 for their proportion of the City business for the year 1938. Said companies being, Reichfield, Shell, Signal and Associated, and that all other companies be given opportunity to share in the city's gasoline business at this rate if they so desire.

Vote Commissioners Krause and Perry and His Honor the Mayor voting eye. Noes, none.

Bids for the purchase of cement were next opened by the City Engineer, and on motion of Commissioner Marble seconded by Commissioner Krause it was moved and carried that the bid of Weitshek Lumber Company for Portland Cement at \$.615 per sack be accepted.

Vote Commissioners Krause Marble and Perry and His Honor the Mayor voting eye. Noes, none.

On motion of Commissioner Marble seconded by Commissioner Krause it was moved and carried that all liquor licenses applied for for the year 1938 be granted. Same having been approved by the Chief of Police.

Vote Commissioners Krause, Marble and Perry and His Honor the Mayor voting eye. Noes, none.

On motion of Commissioner Krause seconded by Commissioner Perry it was moved and carried that the applications for gaming and slot machine licenses for the first quarter year be granted.

Vote Commissioners Krause, Marble and Perry and His Honor the Mayor voting eye. Noes, none.

On motion of Commissioner Marble seconded by Commissioner Krause it was moved and carried that the claim of Roberts and Gravens in the sum of \$426.80 be allowed. This amount covered the cost of new roofing at the grandstand and had been contracted for in October 1937.

Vote was Commissioners Krause, Marble and Perry and His Honor the Mayor voting eye. Noes, none.

On motion of Commissioner Marble seconded by Commissioner Krause it was moved and carried that the Clerk forward to the office of Claude Mackey, WPA Director reports of the WPA project now under construction. Reports being Form No. 710A for 72 man hours \$46.68 and Form 710 39 Truck days total \$292.50.

Vote Commissioners Krause, Marble and Perry and His Honor the Mayor voting eye. Noes, none.

No further business appearing before the Board at this time the meeting recessed and adjourned until Monday the 10th day of January 1938 at the hour of three o'clock P.M.

At this time the Clerk read to the Board a letter from David Mackey Chief of Police where in a report of the conditions of the City Pound and the treatment of animals and their disposal by City Officers was described.
