Minutes of a recessed regular meeting of the Board of Commissioners of the City of Las Vegas held on the 15th day of February, 1938 at the hour of three o'clock P.M.

Present Commissioners Marble, Krause and Ronnow, City Attorney and City Clerk. Mayor Arnett arriving late.

Absent Commissioner Perry.

Minutes of February 8th, 1938 read and approved as read.

At this time bids for the purchase of grass seed for the City of Las Vegas were opened, and upon motion of Commissioner Ronnow seconded by Commissioner Krause it was moved and carried that the bid of the Las Vegas Hardware Co. be accepted. Said bid being \$30.00 per 100 pounds of grass seed. This being the lowest and best bid.

Vote Commissioners Krause Ronnow and Marble voting aye. Noes, none.

Bids for the purchase of lumber were next opened and upon motion of Commissioner Ronnow seconded by Commissioner Krause it was moved and carried that the bid of Weitzel Lumber Company recommended for acceptance but that C.D. Baker accept what in his judgement was the best bid offered.

Vote Commissioners Krause, Marble and Ronnow voting aye. Noes, none.

Bids for the purchase of tires for various departments of the City were next opened, and upon motion of Commissioner Ronnow seconded by Commissioner Krause it was moved and carried that the S.D. Baker be instructed to accept the lowest and best bid. Bids being as follows: Western Auto Supply Co. \$210.40; Mohawk Tire Service \$223.00; A.C. Grant \$242.32; Cashman \$250.97 and General Auto Parts \$238.42.

Vote Commissioners Krause, Ronnow and Marble voting aye. Noes, none.

On motion of Commissioner Ronnow seconded by Commissioner Krause it was moved and carried that the application of Abbia Davis to distribute milk in the City of Las Vegas be referred to the "Milk Ordinance Committee" for investigation and report.

Vote Commissioners Krause, Ronnow and Marble voting aye. Noes, none.

Mr. Tandy appeared before the Board with Mr. Longsinger in regard to Mr. Longsinger securing a years lease on the three front rooms at the Municipal Plunge to be used for a lunch room.

Upon motion of Commissioner Marble seconded by Commissioner Ronnow it was moved and carried that upon the written request of the "Recreation Board" that the the City lease said three rooms to Mr. Longsinger that the City Attorney draw up the proper form of lease and that same be executed by the Mayor and City Clerk. Said lease to be for \$40.00 per month for one year.

Vote Commissioners Krause Ronnow and Marble and His Honor the Mayor voting aye. Noes, none.

At this time the Board continued the discussion of the desirability and advisability of building a municipal golf course at Las Vegas, it appearing to the Board that there is a large amount of unemployment at present in the City and that funds from Federal Government are now available for such purpose, and that the Las Vegas Golf Association has already raised the sum of fifteen hundred dollars (\$1500) to contribute to the City toward the sponsor's contribution of four thousand dollars (\$4000) for such project, and that such project will be a great benefit to the said City, and will be self-supporting when once built, therefore, after general consideration of the matter, it was the unanimous opinion of the members of the Board that proper steps be taken toward the building of such municipal Golf Course. Thereupon on motion of Commissioner Krause seconded by Commissioner Marble, the following Resolution was introduced:

RESOLUTION

WHEREAS, the City of Las Vegas, Clark County, Nevada, has for some time past been desirous of building a Municipal Golf Course at Las Vegas to attract more people to come to this community and build homes and make investments here, and

WHEREAS, the said City of Las Vegas would have built such course ere this time, had there been any way to do so without having the total cost thereof fall upon the taxpayers of said City, and

WHEREAS, it is now possible to obtain from the Government of the United States, financial aid for such project, provided said City will stand sponsor for the cost thereof up to the sum of four thousand dollars (\$4,000.00), and

WHEREAS, the Las Vegas Golf Association has already, by volunteer subscription by and from its members and certain of the business people and citizens of said City, secured the sum of fifteen hundred dollars (\$1500) which it is willing to contribute toward said amount of four thousand dollars (\$4,000) to be paid by said City as the sponsor's contribution, and

WHEREAS, the said Golf Association has represented to said City that such golf course, once built, will be self-supporting and in addition thereto, will produce enough revenue to repay said City the money to be advanced therefor, and

WHEREAS, application for said aid from the United States Government has already been made and because of the present effort of the government to reduce unemployment, the Government is willing that such project go forward, and

WHEREAS, the present number of unemployed people in this community is not altogether too large and is constantly increasing, and

WHEREAS, except for the several Federal Aid Projects now contemplated by said City, there appears no method of caring for said unemployed people, and

WHEREAS, the City deems it a better policy to sponsor Federal Aid Projects, including said golf course, in order to furnish employment to such unemployed persons, than to permit them to become public charges entirely at the expense of the taxpayers, of the City, and

WHEREAS, the said contemplated building of such golf course will furnish employment to a number of such unemployed persons, and

WHEREAS, the said golf course, when completed, will be a great asset to said City, and

WHEREAS, said City already owns land near the present fish hatchery ponds on which said golf course can be built, and

WHEREAS, there are at present no funds in the Treasury of said City not allocated to other purposes, which can be used for such purpose, and by reason of the foregoing facts, an emergency exists sufficient to warrant said City in making a loan of Twenty-five Hundred (\$2500) which can be obtained from the First National Bank of Nevada, Las Vegas Branch, at a rate of interest less than eight per cent per annum,

NOW, THEREFORE BE IT RESOLVED by the Board of Commissioners of the City of Las Vegas, that the City of Las Vegas, Clark County, Nevada, do borrow from the First National Bank of Nevada, Las Vegas Branch, the sum of Twenty-five Hundred Dollars (\$2500) for the term of two and one-half (2½) years, with interest at a rate not to exceed eight per cent per annum and be it further resolved that the Mayor of the said City of Las Vegas, and the City Clerk be and they hereby are authorized and empowered to make, execute and deliver a promissory note or promissory notes on behalf of said City, aggregating the said sum of Twenty-five hundred dollars (\$2500), to be redeemed at the option of this Board at any time when money is available in the emergency tax fund of said City, to be levied by said City at the first tax levy following the creation of such indebtedness, as by law provided.

It was then moved by Commissioner Krause and seconded by Commissioner Marble that action upon said Resolution be deferred until a regular meeting of this Board to be held on the Friday the 4th day of March, A.D. 1938, at the hour of three o'clock P.M. And that the City Clerk be directed to have Notice of said contemplated action of this Board published for at least two publications, one week apart, in the Las Vegas Evening Review Journal, a newspaper of general publication circulation, printed and published in said City of Las Vegas, Clark County, Nevada.

The foregoing Motion, upon being put to vote was carried by the following votes:

Voting AYE: Commissioners Krause; Marble, Bonnow and His Honor the Mayor, Voting no, none.
Absent Commissioner Perry.

On motion of Commissioner Marble seconded by Commissioner Krause it was moved and carried that the City Attorney and City Clerk be directed to forward Mr. Godwin, Regional Director of the FWA all information need to date on the proposed power plant and system for the City of Las Vegas also including application for an advance grant.
Vote Commissioner Krause, Bonnow, and Marble and His Honor the Mayor voting aye. Noes, none.

The business of City Employees paying Accident premiums each month as per Nevada Industrial Commission was next brought before the Board for consideration, and on motion of Commissioner Bonnow seconded by Commissioner Krause it was moved and carried that a resolution passed on the 15th day of January 1936 be rescinded. Said Resolution providing that all employees drawing the sum of \$25.00 per month have the sum allowed by the Nevada Industrial Commission deducted from their salary the 15th day of each month. This sum covering hospitalization only.
Vote Commissioners Krause, Bonnow and His Honor the Mayor L.L. Arnett voting aye. Commissioner Marble voting no. Absent Commissioner Perry.

No further business appearing before the Board at this time the meeting recessed and adjourned until Monday the 21st day of February, 1938 at the hour of three o'clock P.M.

Minutes of a recessed regular meeting of the Board of Commissioners of the City of Las Vegas held on the 21st day of February, 1938 at the hour of three o'clock P.M.

Roll call showed the following present Mayor Arnett, Commissioners Krause, Bonnow and Marble, City Attorney and City Clerk

Absent Commissioner Perry.

Report of Municipal Judge for month of January approved by the Mayor.

Attorney W.L. Scott appeared before the Board as agent for Lenora Castillo in asking for a retail beverage license at the rear of 124 South 1st St. Said license had been denied at a previous meeting. After some discussion on the matter it was still the opinion of the Board that no license for a beverage or liquor business be granted Mrs. Castillo at said location until such time as the Chief of Police would approve the granting of said license applied for. To date his approval had not been obtained.

At this time the Board entered into a general discussion as to the erection of signs in the City of Las Vegas and the same were effected by the City Building Code. After some discussion on the matter on motion of Commissioner Marble seconded by Commissioner Krause it was moved and carried that the City Attorney and City Engineer investigate and list all signs erected or maintained on City property. That the owners of said signs erected or maintained on City property be notified in writing to the effect that same must be removed in five days from receipt of notice and failing to do so the City Engineer shall have said signs removed.
Vote Commissioners Krause, Bonnow Perry and Marble and His Honor the Mayor voting aye. Noes, none.

Forms of agreement from the Standard Oil Company and the Union Oil Company for the purchase of a proportionate part of the road oil required by the City of Las Vegas for the year 1938 were presented to the Board by C.D. Baker City Engineer.

On motion of Commissioner Marble seconded by Commissioner Krause it was moved and carried that the Mayor sign said agreements as same were presented to the Board.
Vote Commissioners Krause, Bonnow, Perry and Marble and His Honor the Mayor voting aye. Noes, none.

Mayor Arnett at this time made verbal application to the Board for a 60 days leave of absence effected from 27th to May 27th, 1938.

On motion of Commissioner Bonnow seconded by Commissioner Krause it was moved and carried that the Mayor be granted said leave of absence.
Vote Commissioners Krause, Bonnow Perry and Marble and His Honor the Mayor voting aye. Noes, none.

No further business appearing before the Board at this time the meeting recessed and adjourned until Monday the 28th day of February, 1938 at the hour of three o'clock P.M.
