

A petition signed by 53 6/10 percent of property owners in Stewart Addition, to the city of Las Vegas requesting that the property be zoned to cover 25 foot set-back and also that the cost of dwellings other than business buildings cost not less than \$2500.00, was presented and referred to the Planning Engineer for recommendation.

A petition signed by several property owners requesting permission to operate a grocery store at 509 Jackson Street, West Side, was read and turned over to Mr. Tinch for investigation.

A letter from the Las Vegas Ministerial Association protesting the leasing of the City Park for dog races was read and the clerk was directed to answer it informing them of the action taken by the Board.

Commissioner Rubidoux moved that the claim of the Nevada Electric in the sum of \$203.00 for heating and cooling at the golf course be allowed. Motion seconded by Commissioner Clark and carried by the following vote. Commissioners Clark, Rubidoux, Tinch and His Honor voting aye. Noes, none.

A letter from Mr. Zaugg was read and referred to the city attorney for answer.

Commissioner Clark moved that the claim of I. R. Stanley in the sum of \$22 be allowed. Motion seconded by Commissioner Rubidoux and carried by the following vote. Commissioners Clark, Rubidoux, Tinch and His Honor voting aye. Noes, none.

Commissioner Tinch moved that the bill for setting T's and fire hydrants in the H.F.M & M tract in the sum of \$33.24 be allowed. Motion seconded by Commissioner Clark and carried by the following vote. Commissioners Clark, Rubidoux, Tinch and His Honor voting aye. Noes, none.

Commissioner Rubidoux moved that the bill of the Heating and Airconditioning Supply Company in the sum of \$350 for fixtures for the west wing of the War Memorial Hall be allowed. Motion seconded by Commissioner Tinch and carried by the following vote. Commissioners Clark, Rubidoux, Tinch and His Honor voting aye. Noes, none.

Commissioner Clark moved that the girls in the city clerk's office and Miss Culley and Miss Ewalt be raised from \$125 per month to \$140 per month beginning as of July 1st, 1942. Motion seconded by Commissioner Tinch and carried by the following vote. Commissioners Clark, Rubidoux, Tinch and His Honor voting aye. Noes, none.

Commissioner Clark moved that Commissioner Tinch be authorized to have bids issued for the necessary wiring and equipment for the kitchen in the new city jail. Motion seconded by Commissioner Rubidoux and carried by the following vote. Commissioners Clark, Rubidoux, Tinch and His Honor voting aye. Noes, none.

Commissioner Rubidoux moved that Ralph Laswell be raised from \$90 per month to \$120 per month and Harry Jamison be raised from \$175 to \$190 per month - said raises to take effect as of June 15th, 1942. Motion seconded by Commissioner Clark and carried by the following vote. Commissioners Clark, Rubidoux, Tinch and His Honor voting aye. Noes, none.

Commissioner Tinch moved that he be allowed to hire four more men to be selected by himself on the police force. Motion seconded by Commissioner Clark and carried by the following vote. Commissioners Clark, Rubidoux, Tinch and His Honor voting aye. Noes, none.

Commissioner Clark moved that the city attorney be authorized to hire a man to do nothing but investigate on prostitution and turn all such evidence over to the police department. Salary to be \$6 per day. Motion seconded by Commissioner Rubidoux and carried by the following vote. Commissioners Clark, Rubidoux, Tinch and His Honor voting aye. Noes, none.

The city attorney was instructed to prepare an ordinance on busses.

Commissioner Clark moved that preparations be made to hire a bond attorney to start a bond issue and also that the Mayor appoint a committee to look into the matter of hiring said attorney. Motion seconded by Commissioner Tinch and carried by the following vote. Commissioners Clark, Rubidoux, Tinch and His Honor voting aye. Noes, none.

Thereafter, His Honor appointed the following committee: Commissioners Smith and Clark to meet with himself.

Commissioner Clark moved that this meeting adjourn until June 22nd, 1942 at the hour of 10:00 A. M. Seconded by Commissioner Tinch and carried by the following vote. Commissioners Clark, Rubidoux, Tinch and His Honor voting aye. Noes, none.

LAS VEGAS, NEVADA

At a recessed regular meeting of the Board of City Commissioners held this 22nd day of June, 1942. Meeting called to order at the hour of 10:00 A. M., By His Honor, Mayor Howell C. Garrison with the following members present: Commissioners Clark, Rubidoux, Smith and Tinch. City Attorney, Paul Ralli, Deputy Clerk, Roy Whipple and city clerk, Helen Scott Reed.

Minutes of the previous meeting were passed until the next regular meeting.

It was moved by Commissioner Tinch seconded by Commissioner and carried by the following vote that the following Order of Street Vacation be confirmed:

ORDER OF STREET VACATION.

Notice having been given and published, according to law, of the intention of the Board of City Commissioners of the City of Las Vegas, Nevada to close and vacate the street between Blocks 3 and 4 of the Church Addition to the city of Las Vegas, as shown on the official plat thereof; a meeting having been held as scheduled in said notice whereat an opportunity to be heard was given to all persons desiring to object to such proposed street vacation; and full consideration having been given to the matter thereafter;

It is, now, therefore, deemed and determined by said Board of City Commissioners that the closing and vacation of said street is for the best interests of the public and that no person will be materially injured thereby;

WHEREUPON, it is by said Board of City Commissioners adjudged and ordered that that portion of the official plat of said Church Addition to Las Vegas, on file and recorded in Book 2 of Plats, page 7, Clark County, Nevada, Records shall be altered in that the Street between Blocks 3 and 4 thereof shall be closed and vacated, and this order shall be duly recorded in the office of the County Recorder of Clark County, Nevada, and shall be endorsed by said Recorder upon the Map of Plat of said Subdivision on file therein, as aforesaid, so as to indicate clearly the portion thereof altered and changed by this order.

Miss Davis appeared before the Board and spoke on behalf of the OPA, requesting office space in the West Wing of the War Memorial Building. His Honor appointed Commissioner Smith and the city engineer to make a report as to the available office space for rental purposes and report back at the next regular meeting.

At this time Mayor Garrison was called from the meeting and Mayor Pro Tem Clark conducted the meeting.

Mr. John Hall, Sanitation Engineer, made a report on the sanitary situation along with certain recommendations relating to conditions in West Side.

Commissioner Smith moved that a policeman detailed on nothing but sanitation on West Side, and to work under the jurisdiction of the Health Department and the police department at a salary of \$6 per day be hired at once. Motion seconded by Commissioner Rubidoux and carried by the following vote. Commissioners Rubidoux, Smith, Tinch and the Mayor Pro Tem voting aye. Noes, none.

Commissioners Smith and Rubidoux were appointed to make a study of the report submitted by the Sanitation Engineer and report at the next regular meeting.

Commissioner Tinch moved that Clem Malone be granted permission to connect up with the well at the cemetery to service his tract with water for 60 days. Said pipe line to be 1 1/2". Motion seconded by Commissioner Rubidoux and carried by the following vote. Commissioners Rubidoux, Tinch and the Mayor pro tem voting aye. Commissioner Smith passed. Noes, none.

The claims of Mr. Neilson and Mr. Mastrianni were referred to the finance commissioner for action.

Commissioner Rubidoux moved that the city grant an easement to the State of Nevada for the purpose of widening Fremont from 14th Street to the city limits. Motion seconded by Commissioner Smith and carried by the following vote. Commissioners Rubidoux, Smith, Tinch and the Mayor Pro Tem voting aye. Noes, none.

The bid of the O. J. Scherer Co., for a sewerpool and septic tank at the Airport Administration Building was opened at this time. This bid being the only one received.

Commissioner Tinch moved that the bid of the O. J. Scherer Co in the sum of \$1470 be accepted, Motion seconded by Commissioner Smith and carried by the following vote. Commissioners Rubidoux, Smith, Tinch and the Mayor Pro Tem voting aye. Noes, none.

Commissioner Smith moved that the application of the U. S. Government for a license to set three poles on city owned property and install and maintain lights and radio antenna on said poles be granted. Motion seconded by Commissioner Rubidoux and carried by the following vote. Commissioners Rubidoux, Smith, Tinch and the Mayor Pro Tem voting aye. Noes, none.

Commissioners Rubidoux and Tinch were appointed to investigate whether beer could be given away at a barbecue in the War Memorial Hall.

Commissioner Tinch moved that the city attorney request the District Judge to comply with the law regarding the hiring of a full time juvenile officer. Motion seconded by Commissioner Smith and carried by the following vote. Commissioners Rubidoux, Smith, Tinch and the Mayor Pro Tem voting aye. Noes, none.

Mayor pro tem Clark at this time requested the city employees to give the fullest cooperation to the drive now being conducted for the collection of scrap rubber.

Commissioner Tinch moved that this meeting adjourn until July 2, 1942 at the hour of 10:00 A. M. for the purpose of signing the payroll only. Motion seconded by Commissioner Rubidoux and carried by the following vote. Commissioners Rubidoux, Smith, Tinch and the Mayor pro tem voting aye. Noes, none.
