PERMIT FOR STREET PREACHING

SALE OF PROPERTY
Housing Authority

Mr. Kennedy presented an option to purchase land from the City of Las Vegas by the Housing Authority, and explained that this property is located west of Marble Manor comprising just less than 2 acres of land. The City Manager further explained that the property would be purchased at approximately \$2900 per acre or a total of \$5,127.50 and requested authorization for signature of this 150 day option.

Thereafter Commissioner Sharp moved the option for the Housing Authority to purchase this property from the City of Las Vegas be approved, the Mayor Pro Tem and Clerk authorized to sign same, and the following resolution adopted:
