- A. BILL NO. 83-51 - AMENDS THE C-V DISTRICT ZONING REGULATIONS RELATING TO TEMPORARY USES AND ESTABLISHES FOR SAID DISTRICT ACCESSORY USES AND EXCLUDED USES.

This Bill was discussed at length amongst the staff and Councilman Christensen. Subject bill was designed to facilitate the various uses by the Convention Authority at Cashman Field in relation to conventions and activities. After much discussion it was felt by Mr. Saylor and Councilman Christensen that a new ordinance should be drafted and introduced to institute a new zone for Cashman Field (not C-V). Mr. Rixse of the Convention Authority will meet with staff on the drafting of the new bill. Mr. Saylor stated that an item on the October 5. agenda allowing various uses at Cashman Field would suffice during the interim period until a new bill could be adopted. Therefore, this Bill will be presented to the full Council at the October 19, 1983 meeting without recommendation. The City Clerk was also instructed not to publish this Bill title.
