2. **Bill No. 99-9** -- Eliminates the Department of General Services

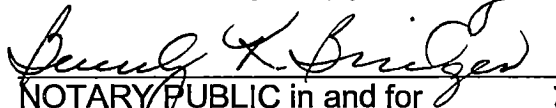

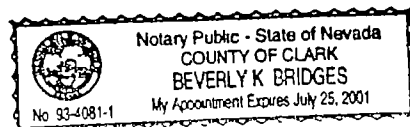
