RESULTS OF CANVASS OF THE SPECIAL ELECTION IN THE CITY OF LAS VEGAS JUNE 22, 2004

The results of the June 22, 2004 Special Election were canvassed comparing the computer printout of ballots counted and the results thereof with the official ballot statements for the 49 precincts used in the election.

Of the 6,093 ballots cast in the 49 precincts, we were unable to reconcile the computer and roster counts in one precinct for one ballot. There were no tabulation errors in the 49 precincts and the foregoing unreconcilable discrepancy would not alter the outcome of any contest.

Therefore, as the duly appointed Registrar of Voters of Clark County, Nevada, I do hereby approve the canvassed results of the Special Election for certification.

TOM McGOWAN, Las Vegas citizen, thanked COUNCILWOMAN MONCRIEF and her staff for action on some of his concerns. He then voiced other concerns, which included his submittals not being returned by staff, and an open meeting violation relating to the Super Speed Train meeting. He asked Council to explain to Taxi Cab Authorities that their duties include residential services as well as commercial.

CITY ATTORNEY BRAD JERBIC clarified for MAYOR PRO TEM REESE and COUNCILMAN BROWN that it was Council's discretion to hear issues unrelated to the canvass during Citizens Participation and suggested it would be best to allow unrelated items to be heard.

PATRICIA MARTINELLI-PRICE, Executive Director of Polly Door Foundation, approached to welcome the new Councilman and stated how she looked forward to working with him. She mentioned her disappointment because MAYOR GOODMAN and COUNCILMAN WEEKLY were not there to welcome COUNCILMAN WOLFSON. COUNCILMAN MACK explained that his colleagues' absence was due to City business out of State.

FRANK PERNA, County resident, voiced concern regarding a lack of homeless shelters. He then expressed the need the City has for Emergency Weather Shelters and/or Drop in Shelters and available services not just in Ward 5. He stated this problem might lead to the involvement of the Federal and State Government, which he dreads.

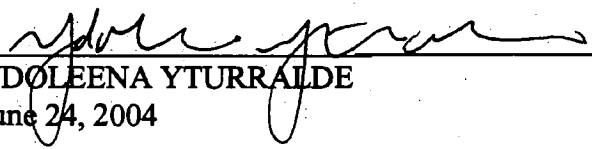
