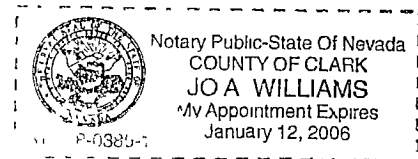

PURPOSE/BACKGROUND:

This bill will increase the base salaries of the Municipal Court judges to \$128,098, commencing July 1, 2004. The increase has been included in the FY 2005 budget approved by the City Council.

RECOMMENDATION:

This bill should be submitted to a Recommending Committee for review, hearing and recommendation to the City Council for final action.

COMMITTEE RECOMMENDATION:

COUNCILWOMAN MONCRIEF recommended Bill 2004-46 be forwarded to the Full Council with a "Do Pass" recommendation. COUNCILMAN WEEKLY concurred.

MINUTES:

COUNCILMAN WEEKLY declared the Public Hearing open.

JIM CARMANY, Court Administrator, Municipal Court, mentioned that he forwarded documentation to COUNCILMAN WEEKLY and COUNCILWOMAN MONCRIEF describing this increase, which does not include a Cost of Living Adjustment (COLA). The money has been budgeted in this fiscal year's budget. MR. CARMANY expressed his support of the increase, indicating that the judges each carry a sizeable caseload. This allows the City to put off hiring another judge for the next six years, which amounts to significant savings. Their efforts in running an efficient Municipal Court will bring in a balanced budget for next year and excess funds for this year's budget season. He noted that Las Vegas Municipal Court Judges are the fourth lowest paid in the State and requested the support of the Recommending Committee

3 **AN ORDINANCE TO INCREASE THE SALARIES OF THE MUNICIPAL COURT JUDGES,**
4 **AND TO PROVIDE FOR OTHER RELATED MATTERS.**

7 THE CITY COUNCIL OF THE CITY OF LAS VEGAS DOES HEREBY ORDAIN
8 AS FOLLOWS:

9 SECTION 1: Title 2, Chapter 26, Section 30, of the Municipal Code of the City of
10 Las Vegas, Nevada, 1983 Edition, is hereby amended to read as follows:

11 **2.26.030:** (A) Except as is otherwise provided in Section 2.26.035, the salary of each
12 Municipal Court Judge shall be [one hundred thirteen thousand five hundred seventy-eight] one
13 hundred twenty eight thousand ninety-eight dollars per year, to take effect July 1, [2002.] 2004.

14 (B) The Municipal Judge who holds seniority in years of service in office, either
15 elected or appointed, is the Chief Judge.

16 SECTION 2: Title 2, Chapter 26, Section 35, of the Municipal Code of the City of
17 Las Vegas, Nevada, 1983 Edition, is hereby amended to read as follows:

18 **2.26.035:** The salaries of the Municipal Court Judges that are provided for in Section 2.26.030
19 shall automatically be increased:

20 (A) On the first day of July, [2003,] 2005, in the same proportion that the index
21 figure of the National Consumer Price Index for All Urban Consumers for All Items, U.S. City
22 Average (1967 = 100) that is published by the Bureau of Labor Statistics, United States Department
23 of Labor, for March of [2003] 2005 has increased above the index figure for March of [2002,] 2004;
24 and

25 (B) On the first day of July in each year thereafter in the same proportion that the
26 index figure for March of that year has increased above the index figure for March of the previous
27 year.

28 SECTION 3: If any section, subsection, subdivision, paragraph, sentence, clause or

1 phrase in this ordinance or any part thereof is for any reason held to be unconstitutional or invalid or
2 ineffective by any court of competent jurisdiction, such decision shall not affect the validity or
3 effectiveness of the remaining portions of this ordinance or any part thereof. The City Council of the
4 City of Las Vegas hereby declares that it would have passed each section, subsection, subdivision,
5 paragraph, sentence, clause or phrase thereof irrespective of the fact that any one or more sections,
6 subsections, subdivisions, paragraphs, sentences, clauses or phrases be declared unconstitutional,
7 invalid or ineffective.

8 SECTION 4: All ordinances or parts of ordinances or sections, subsections, phrases,
9 sentences, clauses or paragraphs contained in the Municipal Code of the City of Las Vegas, Nevada,
10 1983 Edition, in conflict herewith are hereby repealed.
