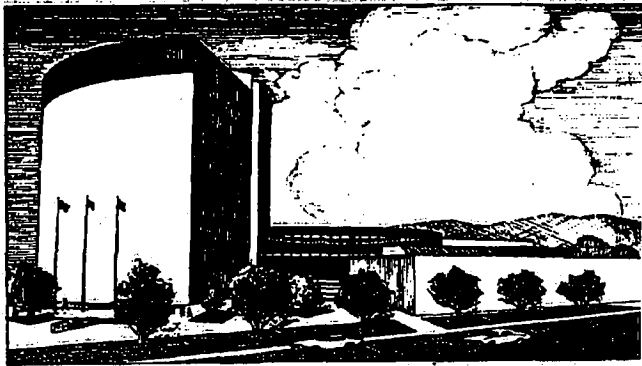

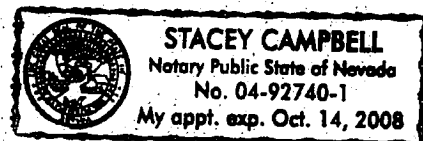

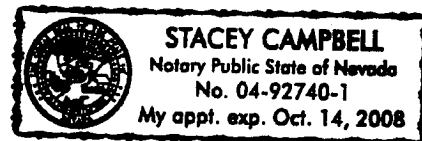

PURPOSE/BACKGROUND:

The City of Las Vegas Special Election for Ward 1 was held on Tuesday, January 25, 2005. As provided by the Clark County Registrar of Voters, the results of this Special Election were canvassed comparing the computer printout of ballots counted and the results thereof with the official ballot statements for the 58 precincts used in this election. Of the 6,902 ballots cast, they were unable to reconcile the computer and roster counts in two precincts for one ballot each. There were no tabulation errors and the foregoing unreconcilable discrepancies would not alter the outcome of the election.

RESULTS OF CANVASS OF THE SPECIAL ELECTION IN THE CITY OF LAS VEGAS JANUARY 25, 2005

The results of the January 25, 2005 Special Election were canvassed comparing the computer printout of ballots counted and the results thereof with the official ballot statements for the 58 precincts used in the election.

Of the 6,902 ballots cast in the 58 precincts, we were unable to reconcile the computer and roster counts in two precincts for one ballot each. There were no tabulation errors in the 58 precincts and the foregoing unreconcilable discrepancies would not alter the outcome of the election.

Therefore, as the duly appointed Registrar of Voters of Clark County, Nevada, I do hereby approve the canvassed results of the Special Election for certification.

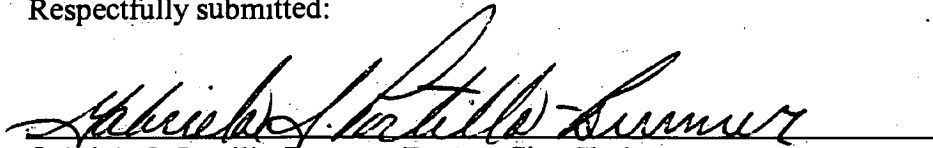
