BOARD ACTION: DISCUSSION AND POSSIBLE ACTION

CLASSIFICATION SPECIFICATIONS:

REVISED:

1. Code Enforcement Officer I/II
2. Traffic Electrician I (X) / Field Electrician II (X)
3. Traffic Electrician I (X) / Traffic Signal Electrician II (X)

Code Enforcement Officer I/II was revised to change the timing of the certification requirements.

Traffic Electrician I (X) / Field Electrician II (X) and Traffic Electrician I (X) / Traffic Signal Electrician II (X) were revised to add a driver's license requirement at the lower level.

NEW:

4. Plant Operations and Maintenance Supervisor

Plant Operations and Maintenance Supervisor was created at the request of the Public Works Department.

RECOMMENDATION

The City recommends approval of these revised and newly created classification specifications.

CODE ENFORCEMENT OFFICER I
CODE ENFORCEMENT OFFICER II

Class specifications are intended to present a descriptive list of the range of duties performed by employees in the class. Specifications are not intended to reflect all duties performed within the job.

DEFINITION

To perform field inspections of properties to ensure compliance with applicable zoning and nuisance codes and ordinances; to resolve complaints; and to perform various related technical duties.

DISTINGUISHING CHARACTERISTICS

Code Enforcement Officer I— This is the entry-level class in the Code Enforcement Officer series. This class is distinguished from the Code Enforcement Officer II by the performance of the more routine tasks and duties assigned to positions within the series including conducting routine field investigations and inspections. This class may contain positions wherein employees perform routine tasks in a permanent basis, and therefore remain at an entry level.

Code Enforcement Officer II— This is the full journey level class within the Code Enforcement Officer series. Employees within this class are distinguished from the Code Enforcement Officer I by the performance of the full range of duties as assigned, including conducting comprehensive investigations and inspections, issuing citations and advising property owners. Employees at this level receive only occasional instruction or assistance as new or unusual situations arise, and are fully aware of the operating procedures and policies of the work unit. Positions in this class are flexibly staffed and are normally filled by advancement from the I level, or when filled from the outside, selected candidates have prior experience.

SUPERVISION RECEIVED

Code Enforcement Officer I

Receives immediate supervision from Code Enforcement Supervisor and higher management staff. Receives technical and functional supervision from the Senior Code Enforcement Officer.

Code Enforcement Officer II

Receives general supervision from Code Enforcement Supervisor and higher management staff. Receives technical and functional supervision from the Senior Code Enforcement Officer.

ESSENTIAL AND MARGINAL FUNCTION STATEMENTS—*Essential and other important responsibilities and duties may include, but are not limited to, the following:*

Essential Functions:

1. Inspect single family and multi-family homes, rental units, apartment buildings, businesses and vacant lots to ensure compliance with current applicable zoning, International Code Council (ICC) Housing and Property Maintenance Codes, nuisance codes, ordinances and regulations; conduct follow-up inspections as necessary; issue notices of violation and assess fees as necessary.
2. Respond to alleged violations; interview complainant and witnesses; take photographs of violations and document activities; communicate in verbal and written form all applicable code information and notification and appeal processes to all parties, tenants, owners, contractors and other agency representatives.
3. Conduct research to determine the approved conditional uses of property; research ownership, compliance requirements, fees, legal process and other state, federal and local requirements necessary to enforce City codes.
4. Inspect property for abandoned or inoperative vehicles; issue citations or infractions to offenders, appear in court, give legal depositions, provide witness information, prepare administrative search warrants, prepare summons and complaint affidavits as required by City Attorney; issue notices for vehicle abatement if necessary; oversee abatement and removal of vehicles.
5. Serve as a resource to other city departments regarding zoning, nuisance, housing and property maintenance code requirements.
6. Maintain detailed, accurate and complete records, case files and reports of inspections and surveillance activities.
7. Operate computer to process and acquire data relative to inspection sites and effective code enforcement, including land use, zoning, court data, licensing, corporation status, county assessor and other databases and agency websites.
8. Respond to and resolve citizen inquiries and complaints.

Marginal Functions:

1. Assist in preparing case reports for court or administrative proceedings; testify in court and at administrative proceedings as necessary.
2. Perform related duties and responsibilities as required.
3. Participate in special community events, including educating citizen groups, attending neighborhood and town hall meetings and television programs.

QUALIFICATIONS

Code Enforcement Officer I

Knowledge of:

Basic applicable city, state and federal codes, ordinances and regulations related to building, zoning, nuisance requirements and International Code Council (ICC) Housing and Property Maintenance Codes.

Basic operational characteristics, services and activities of a code enforcement program.

General construction methods used in building and related structures.

Basic computer use.

Ability to:

Learn to interpret and enforce applicable city, state and federal codes, ordinances and regulations related to zoning, International Code Council (ICC) Housing and Property Maintenance Codes and nuisance violations.

Learn Hansen or other computer applications and to operate computer equipment relative to area of assignment.

Learn to enforce proper zoning, nuisance, health and safety requirements.

Work with diverse cultural and socioeconomic groups using tact, discretion, initiative and independent judgment within established guidelines.

Learn to establish and meet critical deadlines, compile and collect data, establish priorities, organize workload, and conduct necessary follow-up activities with minimal supervision.

Learn to operate modern office equipment, including computers.

Communicate clearly and concisely, both orally and in writing.

Establish and maintain effective working relationships with those contacted in the course of work.

Maintain effective audio-visual discrimination and perception needed for:

- *Making observations;*
- *Communicating with others;*
- *Reading and writing; and*
- *Operating assigned equipment.*

Maintain mental capacity which allows the capability of:

- *Making sound decisions;*
- *Effective interaction and communication with others; and*
- *Demonstrating intellectual capabilities.*

Maintain physical condition appropriate to the performance of assigned duties and responsibilities which may include the following:

- *Sitting, walking and standing for extended periods of time; and*
- *Operating assigned equipment.*

Experience and Training Requirements

Experience:

Two years of work experience which require the frequent interpretation, explanation or enforcement of varied codes and regulations including one year of experience with frequent heavy public contact in stressful or confrontational situations.

Training:

Equivalent to graduation from high school supplemented with college level coursework in building, planning, criminal justice or related field.

License or Certificate

Possession of an appropriate, valid driver's license on the date of application.

Possession of Zoning Enforcement Officer certification, issued by the American Association of Code Enforcement (AACE), within six months of the date of appointment.

Code Enforcement Officer II

In addition to the qualifications for Code Enforcement I:

Knowledge of:

Principles and techniques of inspection.
Operational characteristics, services and activities of a code enforcement program.
Methods and techniques of conflict resolution.
Advanced construction methods used in building and related structures.

Ability to:

Interpret and enforce applicable city, state and federal codes, ordinances and regulations related to zoning, nuisance, housing code and property maintenance issues.
Enforce proper zoning, nuisance, health and safety requirements.
Establish and meet critical deadlines, compile and collect data, establish priorities, organize workload, and conduct necessary follow-up activities with minimal supervision.

Code Enforcement Officer I/II (continued)

Experience and Training Requirements

Experience:

Three years of experience inspecting residential or commercial properties for housing, zoning, building, property maintenance or related code enforcement issues including two years of experience with frequent, heavy public contact in stressful or confrontational situations.

Training:

Equivalent to two years of college-level course work in construction technology, pre-engineering, business administration, criminal justice or a related field.

License or Certificate

Possession of an appropriate, valid driver's license on the date of application.

Possession of a Zoning Enforcement Officer certification, issued by the American Association of Code Enforcement (AACE), on the date of application.

Possession of a Housing and Property Maintenance certification, issued by the American Association of Code Enforcement (AACE), on the date of application.

WORKING CONDITIONS

Constantly = more than 2/3 of the time; Frequently = 1/3 to 2/3 of the time; Occasionally = less than 1/3 of the time; Infrequently = less than 5% of the time.

Environmental Conditions:

Location: Work is performed outdoors up to 80% of the time with exposure to all types of weather conditions.

Hazards: Working in or on public or private property, uneven terrain, exposure to moving objects and vehicles, sharp objects, pinch points, dust, noise, vibration, extreme heat and cold, slippery surfaces, toxic and caustic chemicals.

Equipment Used: City vehicle, radio, measuring equipment, telephone and computer.

Personal Protective Equipment (PPE): Safety shoes, hardhat, hearing protection, safety glasses.

Physical Conditions:

Essential and marginal functions require maintaining physical condition necessary for:

Standing/walking: Constantly-frequently, in combination with walking on all types of terrain, up to 3-5 miles per shift. Can include walking throughout hazardous construction site.

Sitting: Occasionally, while riding in vehicle between inspection sites.

Lift/carry: Frequently, 1-10 lbs., paperwork, clipboards, plans, drawings.

Push/pull: Occasionally, exerting a force up to 10-25 lbs. while inspecting, moving equipment.

Climbing: Occasionally, up and down ladders, walking trusses, in and out of bucket lift.
Requires sense of balance.

Bending/twisting: Frequently, at waist, knees and neck while performing inspection functions and driving vehicle.

Kneeling/crouching/crawling: Infrequent kneeling or crouching, with crawling in attics and crawl spaces.

Hands/arms: Constant use of both hands and arms in reaching, handling, grasping, fingering, gripping while taking measurements, recording data, keyboarding, reviewing plans.

Sight: Constantly, taking accurate measurements, inspecting constructions sites. Requires color vision, visual acuity in near-, mid- and far-ranges.

Speech/hearing: Constantly, in communicating with public and contractors, maintaining safe work environment.

TRAFFIC ELECTRICIAN I
FIELD ELECTRICIAN II

Class specifications are intended to present a descriptive list of the range of duties performed by employees in the class. Specifications are not intended to reflect all duties performed within the job.

DEFINITION

To perform skilled maintenance, repair and installation of electrical systems including street lighting and park lighting; to provide solutions for equipment problems; and to perform a variety of technical tasks relative to assigned areas of responsibility.

DISTINGUISHING CHARACTERISTICS

Traffic Electrician I: This is an entry-level class in the Electrician series. This class is distinguished from the Electrician II classes by the performance of the more routine tasks and duties assigned to positions within the series. This class may be used as a training class, wherein employees may need only limited or no directly related work experience, or the class may contain positions wherein employees perform routine tasks on a permanent basis, and therefore remain at an entry level.

Field Electrician II: This is the full journey level class in the Field Electrician series. Positions at this level are distinguished from the Sr. Field Electrician by the level of experience required to perform the full range of duties as assigned. Employees at this level receive only occasional instruction or assistance as new or unusual situations arise, and are fully aware of the operating procedures and policies of the work unit. Positions in this class are flexibly staffed and are normally filled by advancement from the entry level; when filled from the outside, selected candidates have prior experience.

SUPERVISION RECEIVED

Traffic Electrician I

Receives direct supervision from the Electrical Services Field Supervisor and higher-level staff. May receive functional and technical supervision from a Senior Field Electrician.

Field Electrician II

Receives general supervision from the Electrical Services Field Supervisor or higher-level staff. May receive functional and technical supervision from a Senior Field Electrician.

Traffic Electrician I/Field Electrician II (continued)

ESSENTIAL AND MARGINAL FUNCTION STATEMENTS--*Essential and other important responsibilities and duties may include, but are not limited to, the following:*

Essential Functions:

1. Install, repair and maintain street lighting and park lighting systems.
2. Operate circuit testing equipment, aerial lift equipment, boom trucks, heavy trucks, at times with trailer attached, pneumatic tools, trenchers, diggers, compressors, wire pulling devices, conduit bending equipment, concrete saws, small power tools, hand tools and related equipment.
3. Troubleshoot street lighting and park lighting systems and perform scheduled maintenance.
4. Read and interpret blueprints, schematic drawings and related symbols and markings; locate, identify and mark underground utilities; locate and upgrade code infractions.

Class specifications are intended to present a descriptive list of the range of duties performed by employees in the class. Specifications are not intended to reflect all duties performed within the job.

DEFINITION

To perform skilled maintenance, repair and installation of traffic signal electrical systems; to provide solutions for equipment problems; and to perform a variety of technical tasks relative to assigned areas of responsibility.

DISTINGUISHING CHARACTERISTICS

Traffic Electrician I: This is an entry-level class in the Electrician series. This class is distinguished from the Electrician II classes by the performance of the more routine tasks and duties assigned to positions within the series. This class may be used as a training class, wherein employees may need only limited or no directly related work experience, or the class may contain positions wherein employees perform routine tasks on a permanent basis, and therefore remain at an entry level.

Traffic Signal Electrician II: This is the full journey level class in the Traffic Signal Electrician series. Positions at this level are distinguished from the Sr. Traffic Signal Electrician by the level of experience required to perform the full range of duties as assigned. Employees at this level receive only occasional instruction or assistance as new or unusual situations arise, and are fully aware of the operating procedures and policies of the work unit. Positions in this class are flexibly staffed and are normally filled by advancement from the entry level; when filled from the outside, selected candidates have prior experience.

SUPERVISION RECEIVED

Traffic Electrician I

Receives direct supervision from the Traffic Signal Field Supervisor and higher-level staff. May receive functional and technical supervision from a Senior Traffic Signal Electrician.

Traffic Signal Electrician II

Receives general supervision from the Traffic Signal Field Supervisor or other higher-level management staff. May receive functional and technical supervision from a Senior Traffic Signal Electrician.

ESSENTIAL AND MARGINAL FUNCTION STATEMENTS--*Essential and other important responsibilities and duties may include, but are not limited to, the following:*

Essential Functions:

1. Install, repair and maintain traffic signal systems, including poles, vehicle and pedestrian indicators, light fixtures, fuses, mast arms, illuminated signs, electronic eyes for traffic signal and flasher devices, underground cable and service entrance equipment.
2. Operate circuit testing equipment, aerial lift equipment, boom trucks, heavy trucks, at times with trailer attached, pneumatic tools, trenchers, diggers, compressors, wire pulling devices, conduit bending equipment, concrete saws, small power tools, hand tools and related equipment.
3. Troubleshoot traffic signal systems, and perform scheduled maintenance.
4. Read and interpret blueprints, schematic drawings and related symbols and markings; locate, identify and mark underground utilities; locate and upgrade code infractions.
5. Operate a boom truck and ladder to install, maintain and repair traffic signal systems and traffic light poles involved in accidents.
6. Respond to public inquiries in a courteous manner, provide information within the area of assignment; resolve complaints in an efficient and timely manner.
7. Adhere to all related codes and regulations for duties assigned including obtaining required permits; adhere to safe work practices and procedures; maintain, repair and set up devices for work zone traffic control and worker safety; ensure public safety is maintained during work activities.
8. Retrieve work orders and resolve problems using office computer system.
9. Perform maintenance and repair work involving concrete, plumbing, iron, steel and rough painting,

Marginal Functions:

1. Assist in estimating time, materials, and equipment required for jobs assigned and requisitioning materials as required. Verify manifests upon receipt and inspect materials delivered by vendors; move materials into storage.
2. Perform rough carpentry and concrete work in the course of installing and maintaining traffic signals and related equipment.
3. Respond to traffic signal emergencies during evenings and weekends.
4. Perform related duties and responsibilities as required.

Basic preventive maintenance techniques and procedures.
Occupational hazards and standard safety practices necessary in the area of work assigned.
Basic principles of mathematics applying to electrical and related work.
Basic techniques for reading and interpreting blueprints, schematics, symbols, drawings and related materials.
Basic principles of lineman work.
Basic repair of traffic signals and connecting wiring.
Heavy equipment operation.
Basic first aid practices used in electrical emergencies.
Pertinent federal, state, and local laws and regulations.
Basic techniques and procedures of painting.

Ability to:

Perform semi-skilled maintenance and repair work related to traffic signal electrical systems and components.
Read and understand department policies and procedures.
Operate a variety of vehicular, stationary, and electrical repair equipment in a safe and effective manner.
Read and follow traffic signal maintenance procedures.
Read and understand traffic signal field circuitry.
Drive and operate aerial lift equipment.
Work in aerial lift equipment on poles and at heights up to 80 feet.
Work near connected electrical circuits.
Distinguish colors.
Read and interpret electrical schematics, diagrams, drawings and plans at a basic level.
Learn to troubleshoot and solve basic electrical system defects.
Understand and follow oral and written instructions and sketches.
Work independently without constant supervision.
Communicate clearly and concisely, both orally and in writing.
Establish and maintain effective working relationships with those contacted in the course of work.

Ability to:

Maintain physical condition appropriate to the performance of assigned duties and responsibilities, which may include the following:

- *Walking, standing or sitting for extended periods of time; and*
- *Operating assigned equipment.*

Maintain effective audio-visual discrimination and perception needed for:

- *Making observations;*
- *Communicating with others;*
- *Reading and writing; and*
- *Operating assigned equipment.*

Maintain mental capacity, which allows the capability of:

- *Making sound decisions;*
- *Effective interaction and communication with others; and*
- *Demonstrating intellectual capabilities.*

Experience and Training Requirements

Experience:

One year of experience in the electrical maintenance, electrical construction or electronic fields.

Training:

Equivalent to graduation from high school supplemented by specialized training in the electrical or electronic fields.

License or Certificate

Possession of a valid driver's license on the date of application.

Traffic Signal Electrician II

In addition to the qualifications for Traffic Electrician I:

Knowledge of:

Operations, services, activities, methods and techniques of traffic signal electrical services.

Principles, practices, theories and materials of the electrical trade.

Properties and principles of electricity.

Operational characteristics of mechanical and hydraulic equipment and tools used in the installation, maintenance, and repair of electrical systems.

Preventive maintenance techniques and procedures.

Techniques of electrical troubleshooting and diagnosis.

Principles of mathematics applying to electrical and related work.

Electrical calculation and design techniques.

Blueprints, schematics, symbols, drawings and related materials.

Principles of lineman work.
Traffic work zone safety practices.

Independently perform skilled maintenance and repair work related to traffic signal electrical systems and components.
Read and interpret department policies and procedures.
Analyze and interpret problems in traffic signal systems.
Read and interpret electrical schematics, diagrams, drawings and plans.
Troubleshoot and solve electrical system defects.

Experience and Training Requirements

Experience:

Two years of increasingly responsible journey-level electrical experience.

Training:

Equivalent to graduation from high school supplemented by specialized training in the electrical field.

License or Certificate

Possession of an appropriate, valid commercial driver's license on the date of application.

By the date of application, must possess or have completed any one of the following four:

1. A journeyman electrician card from a recognized union, such as the International Brotherhood of Electrical Workers (IBEW).
2. An apprenticeship from an organization such as a chapter of the Associated Builders and Contractors (ABC), or a union such as the IBEW.
3. Official mailed test results from the International Code Council indicating a passing score on the Standard Journeyman Electrician or Standard Master Electrician examination. Examination must have been taken within three years of the date of application. The Standard Journeyman Sign Electrician and the Standard Journeyman Residential Electrician examinations are not acceptable.
4. A current Clark County, Nevada, Journeyman Electrician or Master Electrician ID card.

Possession, and maintenance, of a current Clark County Journeyman Electrician or Master Electrician ID card within 6 months of the date of appointment.

License or Certificate (continued)

Possession of a Forklift Certificate from the City of Las Vegas within 6 months of the date of appointment.

Possession of an appropriate aerial lift certification from the City of Las Vegas within 6 months of date of appointment.

Possession of a Work Zone Safety Certification from the International Municipal Signal Association, Inc., or equivalent, within six months of the date of appointment.

Possession of Level I Traffic Signal Electrician Certification from the International Municipal Signal Association, Inc. within six months of meeting the certification qualifications.

WORKING CONDITIONS

Constantly = more than 2/3 of the time; Frequently = 1/3 to 2/3 of the time; Occasionally = less than 1/3 of the time; Infrequently = less than 5% of the time.

Environmental Conditions:

Location: Work is primarily performed out of doors, subject to typical Nevada weather.

Hazards: Exposure to noise, dust, grease, fumes, high voltage, extreme heat, electrical energy, working at heights on scaffolding, ladders, aerial lift equipment, working underground in confined spaces, on slippery and uneven surfaces, and work around moving equipment and heavy construction equipment.

Equipment Used: City aerial lift truck, backhoe, trenching machine, asphalt and concrete cutter, jackhammer, variety of hand and power tools.

Safety Equipment: Steel-toed shoes, gloves, safety glasses, goggles, back brace, hearing protection, safety vest, hard hat, rubber gloves, insulated equipment, and safety lanyard while working at heights.

Physical Conditions:

Essential and marginal functions require maintaining physical condition necessary for:

Standing/walking: Frequently, throughout work shift, up to 1 mile per shift. Can be extended based on assignment.

Sitting: Occasionally, while operating vehicle to and from job assignments.

Lift/carry: Frequently, between 1-80 lbs., hand and power tools, aluminaire arms, traffic signal poles, traffic signals and plumbing devices. Usual carry between 20-30 ft. Infrequently, up to and exceeding 100 lbs., while lifting and carrying spools of wire, adapter plates, traffic signal 5-section heads, jackhammers. Assistance from others is available for lifting over 100 lbs.

Push/pull: Frequently-constantly, using one or both arms or hands, exerting a force (typically 20-100 lbs.) moving heavy or awkward equipment, suspended from a hoist, onto boom truck lift bucket, moving steel rebar and bolts while setting new traffic signals at ground level, using jackhammers and other power tools.

Traffic Electrician I/Traffic Signal Electrician II (*Continued*)

Physical Conditions:

Climbing: Frequently, on and off boom truck, in and out of vehicle using steps (16-18"), climbing in and out of lift bucket, on ladders, on and off backhoe and trencher equipment throughout work shift. Requires balance while working in lift bucket, and working at heights up to 80 ft. Must be able to balance heavy load while climbing ladders and in lift truck.

Bending/twisting: Frequently-constantly, at waist, knees and neck throughout work shift, depending on assignments. Some assignments may require constant bending and stooping while working at street level. Worker must be able to crawl in and out of lift bucket up to several times per shift.

Kneeling/crouching/crawling: Frequently, depending on assignments. Crawling, infrequently.

Hands/arms: Constant use of both hands and arms in reaching, handling, grasping, fingering and gripping while handling heavy and awkward materials, hand and power tools. Subject to excessive gripping and vibration. Work is frequently at or above shoulder height.

Sight: Constantly, with ability to distinguish colors, depth perception, hand, eye and foot coordination. Visual acuity in near-, mid- and far-range required, as worker is exposed to extreme traffic hazards.

Speech/hearing: Constantly, must be able to communicate clearly on two-way radio and with co-workers throughout shift.

Other physical demands: Some work assignments require extended stooping and bending working at lower levels throughout work shift. May involve movement of heavy steel and concrete parts and manhole covers while installing traffic signals. Worker must exercise good judgment and have an ability to lift heavy items.
