
RE: STREET NAME CHANGE - SNC-1-99

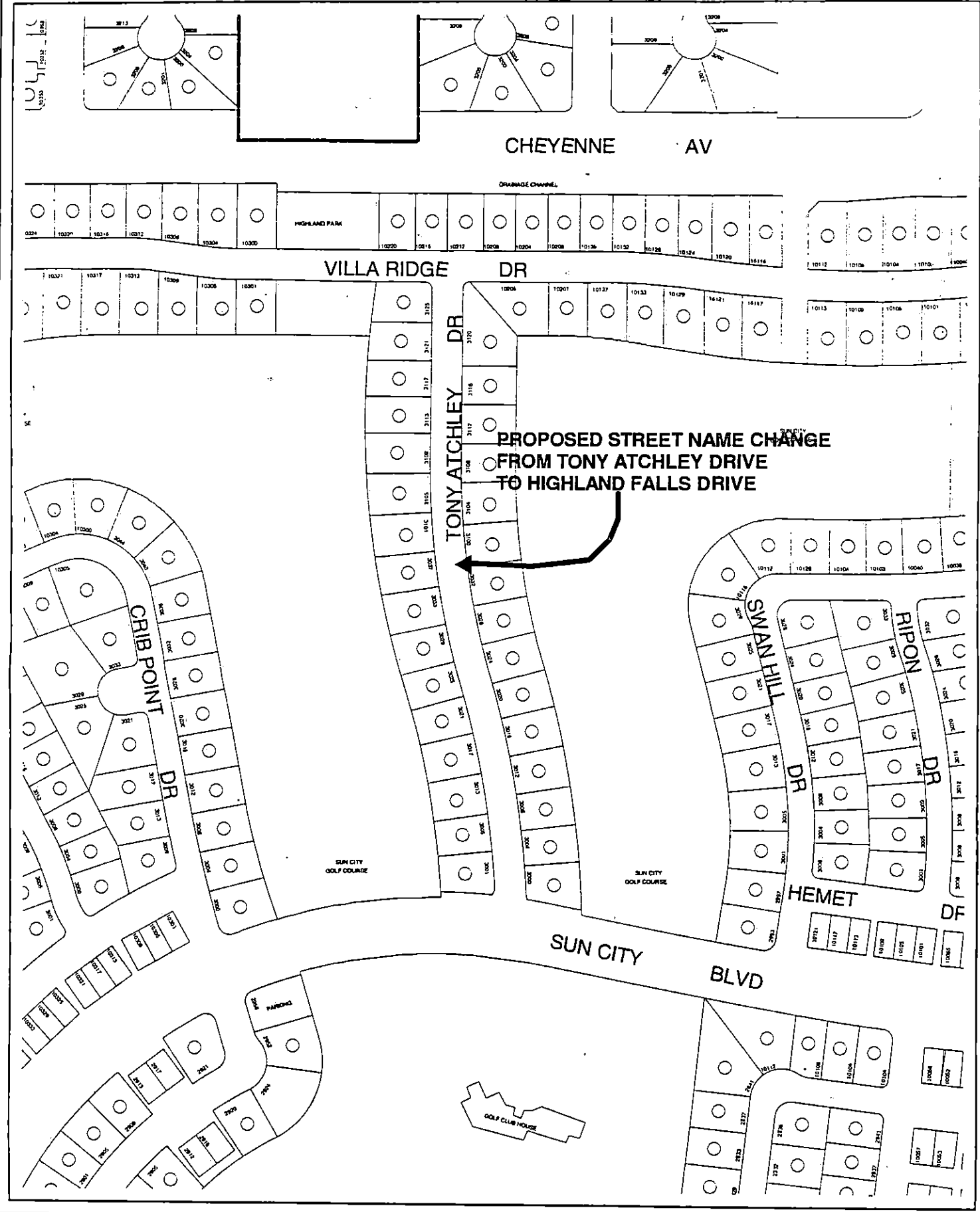
