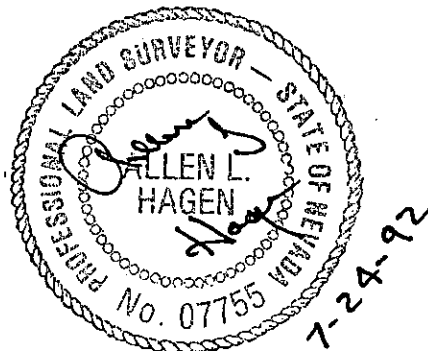
1. All of the building setback lines, together with all references thereto on Sheets 3 through 6, inclusive, are to be deleted.
