3. On Sheet 3 of 4, Village Center Drive and Golf Center Drive both be revised to Village Center Circle.
4. On Sheet 3 of 4, Town Center Drive shown southwest of and northwest of "Summerlin Village 1 South - Unit No. 4" be revised to Village Center Circle. ~~See Exhibit "A" attached to and made a part hereof.~~
5. On Sheet 3 of 4, Town Center Drive shown north of "Summerlin Village 1 South - Unit No. 4" be revised to Hills Center Drive. ~~See Exhibit "A" attached to and made a part hereof.~~
6. On Sheet 4 of 4, in Detail A, Town Center Drive be revised to Village Center Circle.
7. On Sheet 4 of 4, in Detail C, Village Center Drive be revised to Village Center Circle.

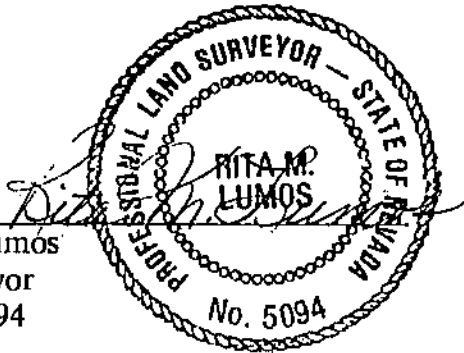
