

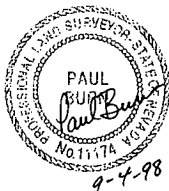
1. **On Sheet 3 of 3, the street name be corrected as follows: Hill Canyon Avenue be revised to Oak Crest Avenue.**
