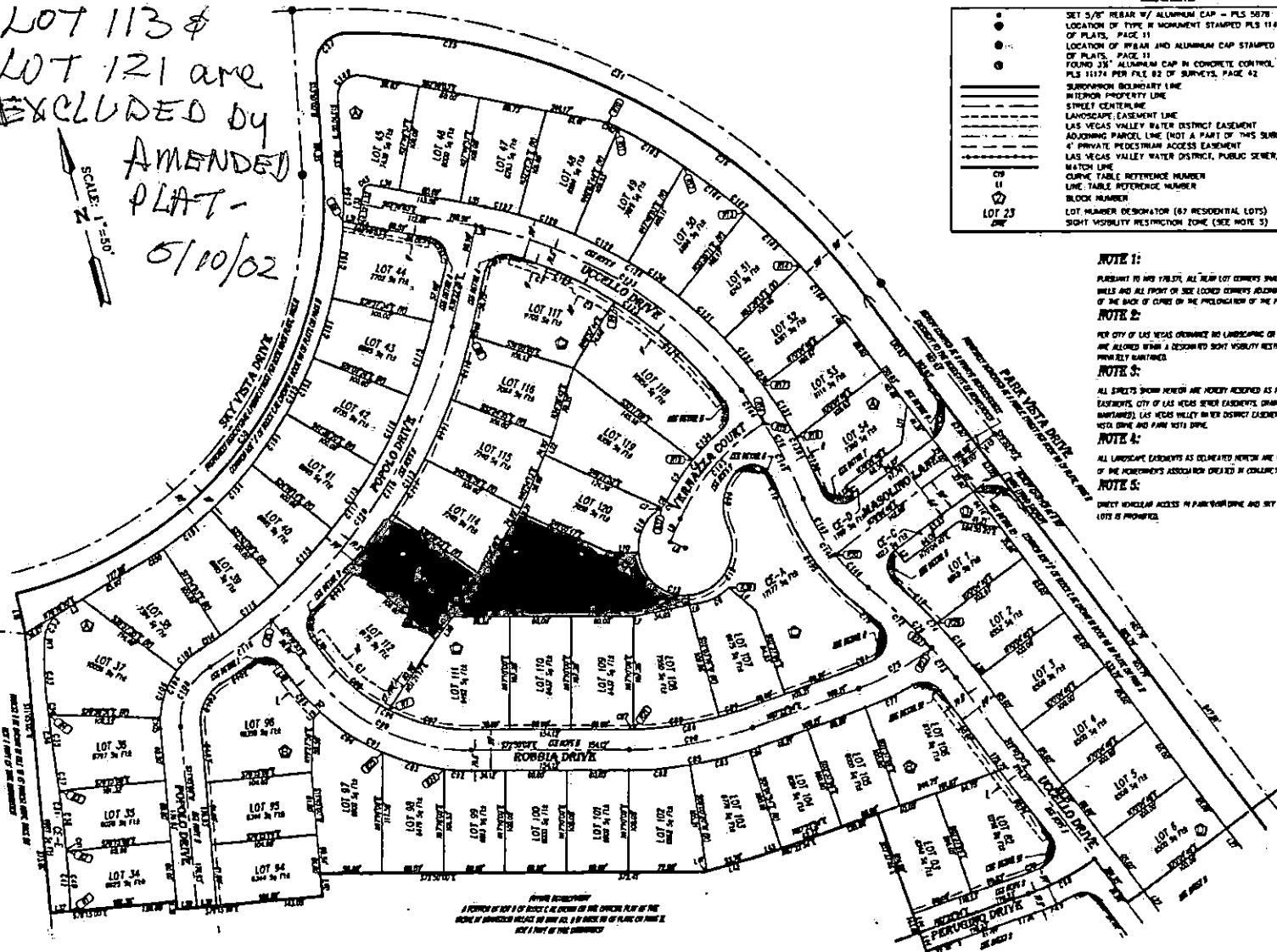

PERMANENT TO AND FROM ALL NEAR LOT CORNERS SHALL BE SET BY A LINE AND TAB "PLS 5078" ON BLOCK WALLS AND ALL FRONT OR SIDE LOCATED CORNERS ALONGING RIGHT-OF-WAY SHALL BE MARKED BY THE SHEETING OF THE BACK OF CURBS OF THE PROLONGATION OF THE PROPERTY LINES.

NOTE 2:

PER CITY OF LAS VEGAS ORDINANCE NO. 400000, ALL RESTRICTED IMPROVEMENTS TALLER THAN 30 INCHES ARE ALLOWED WITHIN A DESIGNATED SHORT VISIBILITY RESTRICTION ZONE. SHORT VISIBILITY ZONES ARE TO BE PROPERLY MAINTAINED.

NOTE 3:

ALL STREETS SHOWN HEREON ARE HEREBY ACCEPTED AS PRIVATE STREETS AND GRANTED AS PUBLIC UTILITY EASEMENTS. CITY OF LAS VEGAS SENIOR EASEMENTS, DRAINAGE EASEMENTS, EASEMENTS TO BE PROPERLY MAINTAINED, LAS VEGAS VALLEY WATER DISTRICT EASEMENTS, NON PUBLIC UTILITY EASEMENTS (PUE), EXCEPT SKY VISTA DRIVE AND PUE VISTA DRIVE.

NOTE 4:

ALL LANDSCAPE EASEMENTS AS DELINEATED HEREON ARE HEREBY ACCEPTED AND OFFERED FOR THE EXCLUSIVE USE OF THE HOMEOWNERS ASSOCIATION CREATED IN CONNECTION WITH THIS PROJECT.

NOTE 5:

DIRECT VEHICULAR ACCESS IN PARKING DRIVE AND SKY VISTA DRIVE THROUGH CORNER LOT "J" FROM ANY LOT IS PROHIBITED.
