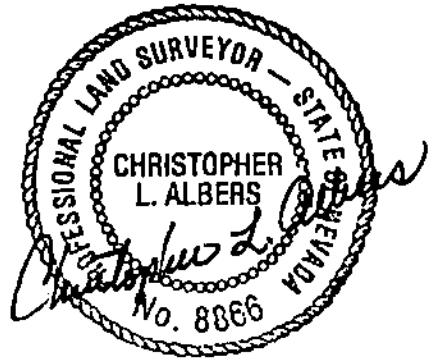
Dear Ms. Lumos,

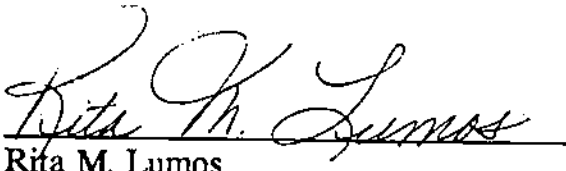
