ORDER OF STREET NAME CHANGE

A petition, dated the 10th day of February, 1997, signed by an abutting property owner on the streets affected thereby, having been filed with the Secretary of the Planning Commission of the City of Las Vegas, Nevada, petitioning for a change of name of the streets hereinafter described, and said petition having been submitted to the City Planning Commission for its recommendation, and said Planning Commission having filed its report with said Council approving and recommending such change of street name;

And said Council, at its regular meeting held on the 14th day of April, 1997, having set the 28th day of April, 1997, at the hour of 2:00 p.m., at the Council Chambers of the City Hall, 400 East Stewart Avenue, Las Vegas, County of Clark, Nevada, as the date, time and place for a public hearing on said petition and recommendation, and the City having undertaken to notify by registered mail each owner of property abutting the area proposed for such street name changes and to cause a notice to be published at least once in a newspaper of general circulation in the City setting forth the time and place of the public hearing and the extent of the proposed street name changes;

And it appearing from the Affidavit of Mailing and the Affidavit of Publication filed with the City Clerk, that notices were mailed on the 15th day of April, 1997, and the notice of hearing was published on the 17th day of April, 1997;

And the City Council, on the 28th day of April, 1997, having held a public hearing on said petition for change of street names and on the recommendation of the City Planning Commission thereon, at which evidence in support of and against said petition was heard;

And the City Council having approved said petition at the hearing by finding that said name changes are in the best interest of the public and that no person will be materially injured thereby;

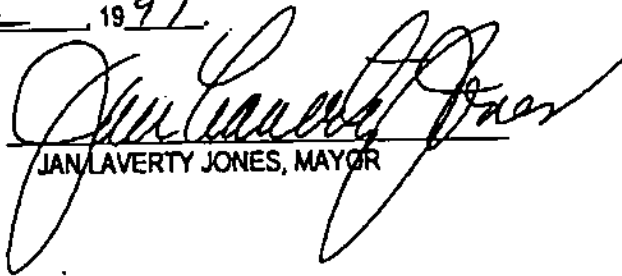
