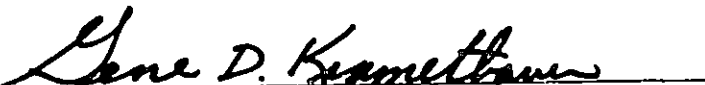

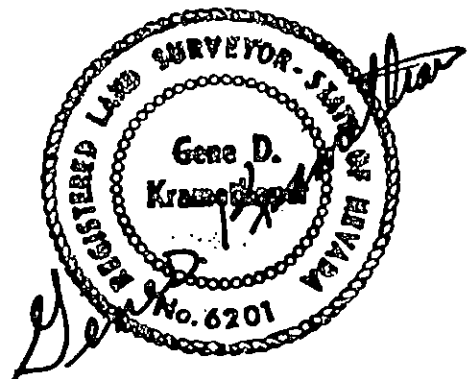
Block bounded by Pompano Beach Lane, Maplewood Way, Hamilton Beach Lane and Capetown Way should be changed from Block 8 to Block 2.

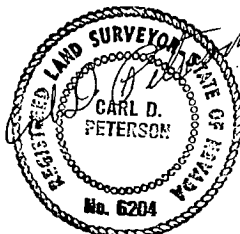

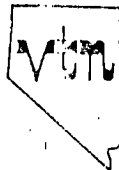
