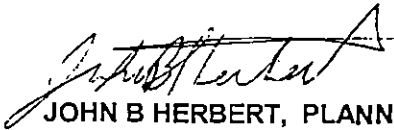

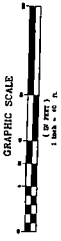

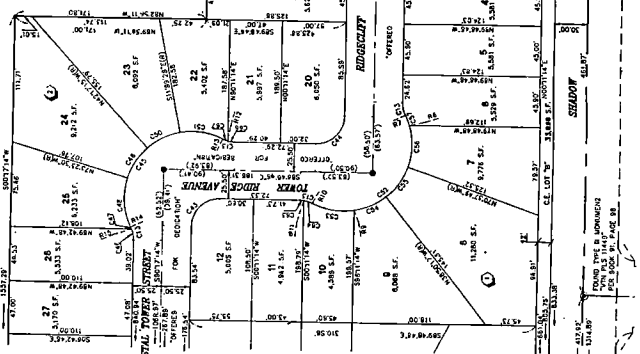


NOTES:

1. ALL REAR LOT CORNERS SHALL BE SET WITH A NAIL AND BRASS TAG TO BE PLACED IN THE ROCK HILL AND ALL FRONT AND SIDE LOT CORNERS MARKED WITH CONCRETE OR METAL PIPES. ALL CORNERS SHALL BE MARKED BY THE SAW CUTTING OF THE BACK OF CORNERS ON THE PERMANENCE OF THE PROPERTY LINES.
2. DIRECT VEHICULAR ACCESS TO CHEVYNE AVENUE AND SHADOW PEAK STREET THROUGH COMMON ELEMENT LOT 5 FROM ANY OTHER LOT IS PROHIBITED.
3. SEE SHEET 4 FOR CURVE, CORNER, AND RADIAL LINE TABLES.
