Seward's Bluff Avenue should be amended to read Searwards Bluff Avenue.

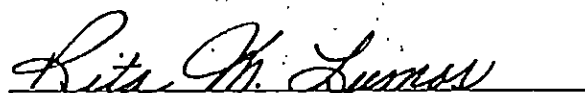
