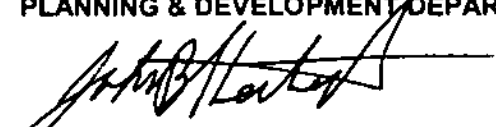

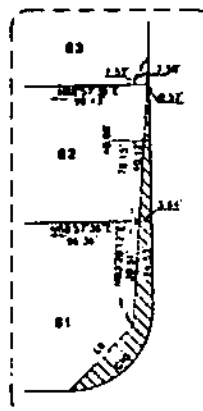

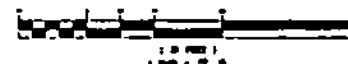
DETAIL 'A'

2. STREET VEHICULAR ACCESS TO DURANGO DRIVE FROM ADJOINING LOTS IS PROHIBITED.

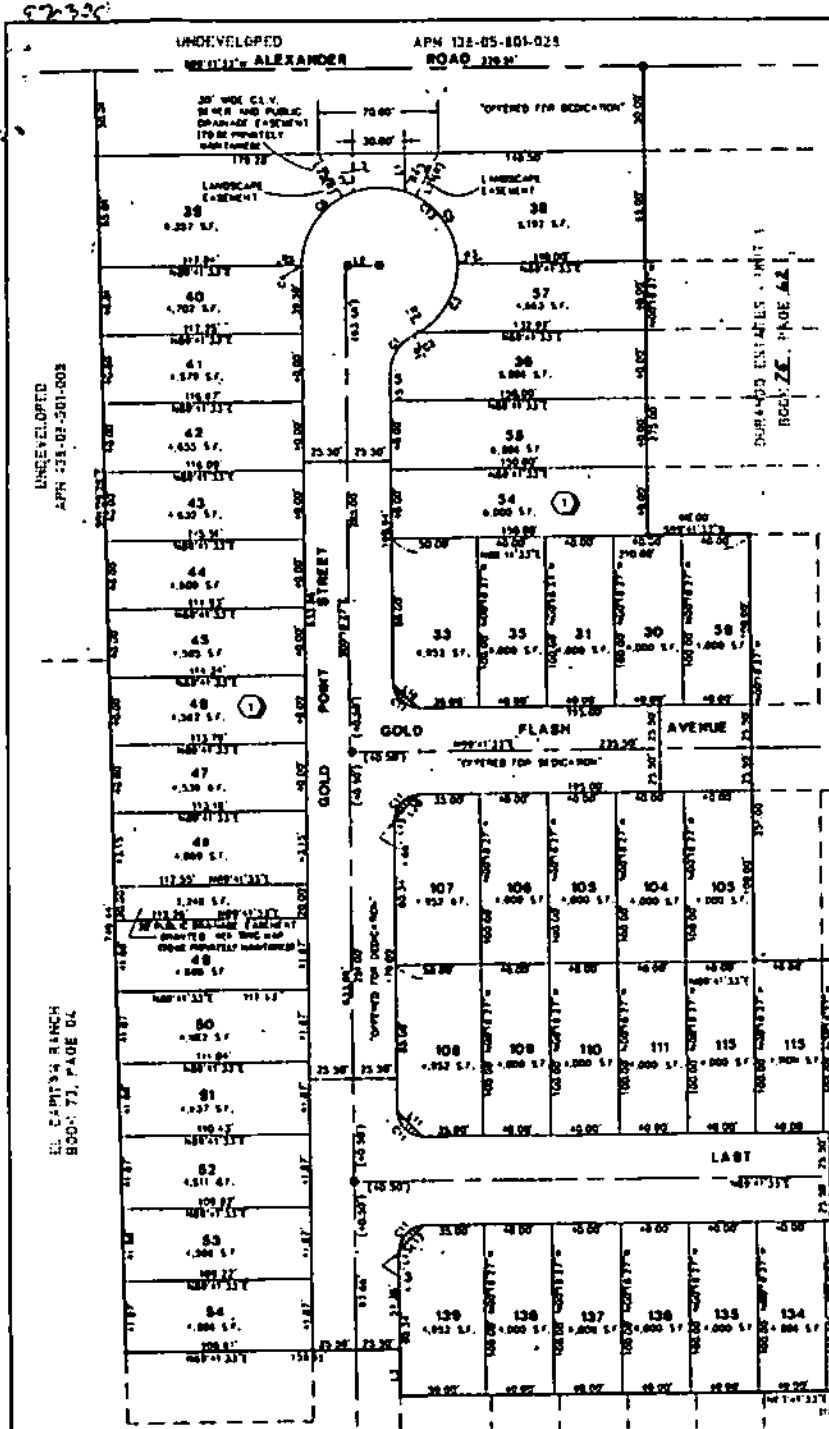
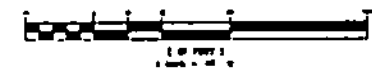
