1. CONSTRUCT 6 FOOT HIGH DECORATIVE BLOCK WALLS WITH 20 FEET BY 5 FEET WALL INSETS EVERY 50 FEET ALONG DECATUR BOULEVARD AND GILMORE AVENUE AS REQUIRED BY THE DEPARTMENT OF COMMUNITY PLANNING AND DEVELOPMENT.
2. NO HORSES SHALL BE PERMITTED.
3. ALL HOMES AND ACCESSORY STRUCTURES SHALL CONFORM TO THE R-1 ZONING DISTRICT REQUIREMENTS. THE BUILDING SETBACKS SHALL BE AS FOLLOW: FRONT: 20 FEET, REAR: 15 FEET, SIDE: 5 FEET (15 FEET CORNER LOT).
4. DEDICATE 30 FEET OF RIGHT-OF-WAY FOR GILMORE AVENUE AND A 25 FOOT RADIUS ON THE NORTHWEST CORNER OF DECATUR BOULEVARD AND GILMORE AVENUE AS REQUIRED BY THE DEPARTMENT OF PUBLIC WORKS.
5. CONSTRUCT HALF-STREET IMPROVEMENTS ON GILMORE AVENUE AND DECATUR BOULEVARD AS REQUIRED BY THE DEPARTMENT OF PUBLIC WORKS.
6. EXTEND THE PUBLIC SANITARY SEWER IN GILMORE AVENUE TO THE WEST PROPERTY LINE OF THIS DEVELOPMENT AS REQUIRED BY THE DEPARTMENT OF PUBLIC WORKS.

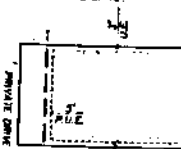
