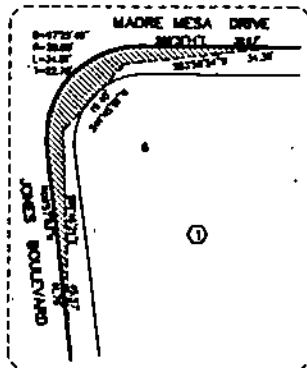

NOTES

1. ALL REAR LOT CORNERS SHALL BE SET WITH A NAIL AND BRASS TAIL "PLS 7008" ON BLOCK WALLS AND ALL FRONT OR SIDE CORNERS ADJOINING PUBLIC RIGHT-OF-WAY, SHALL BE MARKED BY THE SET OUTTING OF THE BACK OF CURBS ON THE PROLONGATION OF THE PROPERTY LINES.
2. SIGHT VISIBILITY RESTRICTION ZONE (SVRZ) - NO WALLS, FENCES, TREES, BUSHES, UTILITY APPURTENANCES OR ANY OTHER OBJECT, OTHER THAN TRAFFIC CONTROL DEVICES AND STREET LIGHT POLES, MAY BE CONSTRUCTED OR INSTALLED WITHIN THE SVRZ, UNLESS SAID OBJECT IS MAINTAINED AT LESS THAN 24 INCHES IN HEIGHT, MEASURED FROM ADJACENT TOP OF CURB, OR WHERE NO CURB EXISTS, A HEIGHT OF 77 INCHES, MEASURED FROM THE TOP ADJACENT ASPHALT, GRAVEL OR PAVEMENT STREET SURFACE. SIGHT VISIBILITY RESTRICTION ZONES SHALL BE PERMANENTLY MAINTAINED.
3. LOTS 1 AND 7 SHALL FRONT ON MADRE MESA DRIVE.
4. DIRECT VEHICULAR ACCESS TO JONES BOULEVARD FROM LOT 5 AND 6, BLOCK 1, IS PROHIBITED.
