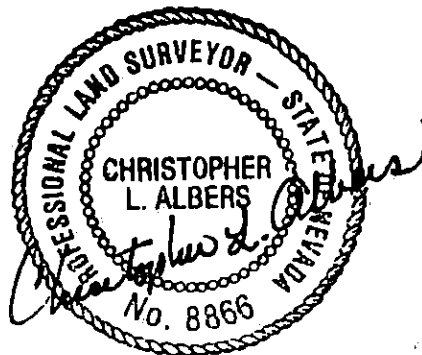

1. On Sheets 2, 3, 5, 6, 7 and 8 of 13, Town Center Drive be revised to Hills Center Drive.

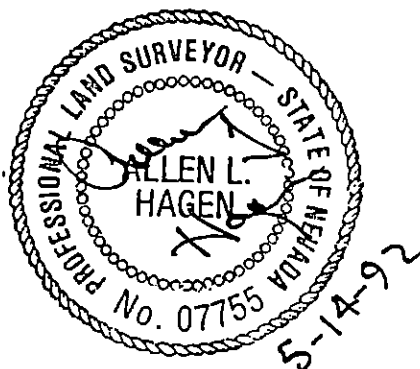
