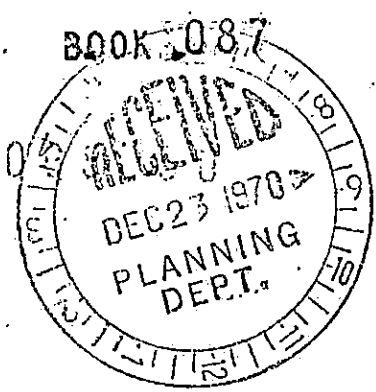

ORDER CHANGING NAME
of
TERESA AVENUE TO THERESA AVENUE

WHEREAS, the Board of Commissioners of the City of Las Vegas set a public hearing, pursuant to NRS 116.120, on the proposed change of street name of Teresa Avenue between Meyer Street and MacFarlane Street and between 30th Street and James Street to Theresa Avenue and gave notice thereof as required by law, which public hearing was duly held on the 2nd day of December, 1970; and

WHEREAS, at said public hearing all persons were given an opportunity to protest and be heard; and

WHEREAS, the following proposed street name change was approved by the Board of Commissioners and said Commission finds that said street name change will facilitate public convenience and be beneficial to the City of Las Vegas.

NOW, THEREFORE, IT IS HEREBY ORDERED by the Board of Commissioners of the City of Las Vegas, Nevada, that Teresa Avenue between Meyer Street and MacFarlane Street and between 30th Street and James Street be, and the same hereby is, changed to Theresa Avenue.

IT IS FURTHER ORDERED that all plats recorded in the Office of the County Recorder of Clark County, Nevada, be altered or changed to reflect said street name change.

IT IS FURTHER ORDERED that a certified copy of this Order be recorded in the County Recorder's Office in Clark County, Nevada, as required by law.

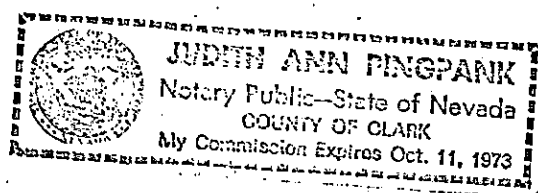
