CERTIFICATE OF AMENDMENT - CONCORD VILLAGE SUBDIVISION PHASE I

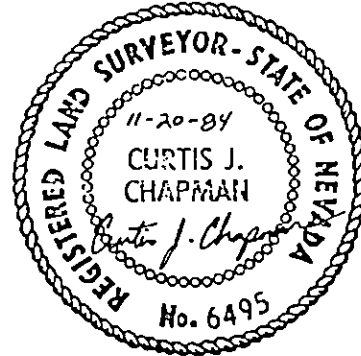
Dear Mr. Peterson:

The plat gives the name of an existing roadway as Ann Greta Avenue when in fact this roadway is named Ann Greta Drive.

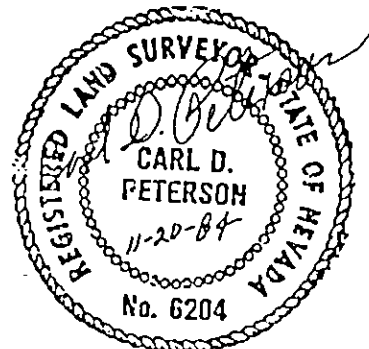
I do hereby certify that this correction does not change or purport to change the physical location of any survey monument, property line or boundary line.
