RE: Z-42-85 - PLOT PLAN REVIEW

Gentlemen:

Your request for a Plot Plan Review regarding proposed custom home lots on property located on the northeast corner of Lake South Drive and Crystal Water Way, N-U Zone (under Resolution of Intent to R-PD12), was considered by the Planning Commission on December 13, 1990.

The Planning Commission unanimously voted to APPROVE your request, subject to the following:

1. File an application to rezone the property to R-PD1 prior to the issuance of the first building permit for the homes.
2. The Reversionary Map for Emerald Bay Lakeside Villas must be recorded prior to the recordation of a Parcel Map to create the four lots.
3. The setbacks shall be a minimum of 20 feet in the front yard, 20 feet in the rear yard and 10 feet on each side.
4. Construct all incomplete half-street improvements on Lake South Drive and on Crystal Water Way as required by the Department of Public Works.
5. Provide public sewer easements for all public sewer not constructed within public rights-of-way as required by the Department of Public Works.
6. Conformance to the plot plan.
7. Satisfaction of City Code requirements and design standards of all City departments.
