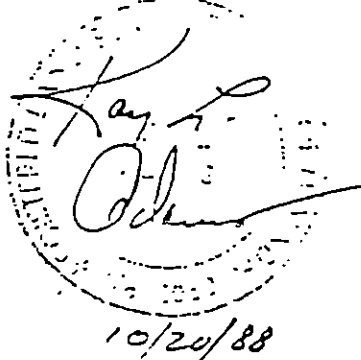
- o Diamond Springs Drive shall be revised to Medalist Drive.
