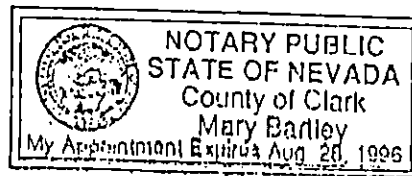

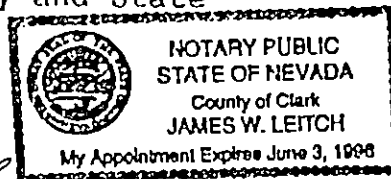

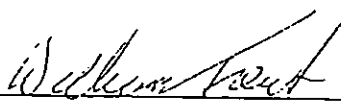
RELEASE AND INDEMNIFICATION

thirds of the mortgage lenders as required by that section.

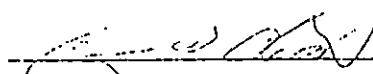
2. In the event any claim, demand, or legal action is instituted
