ORDER AMENDING SUBDIVISION PLATS

WHEREAS, the Board of Commissioners of the City of Las Vegas set a public hearing, pursuant to NRS 116.120, on the proposed amendment of the following described plats within the City of Las Vegas to eliminate the provision in the dedication on said plats denying access to Decatur Boulevard from certain lots thereon, and gave notice thereof as required by law, which public hearing was duly held on the 22nd day of October, 1969; and

WHEREAS, at said public hearing all persons were given an opportunity to protest and be heard; and

WHEREAS, the following proposed amendment in said subdivision plats was approved by the Board of Commissioners and said Board finds that said amendment will facilitate public convenience and be beneficial to the City of Las Vegas.

NOW, THEREFORE, IT IS HEREBY ORDERED by the Board of Commissioners of the City of Las Vegas, Nevada, that the provision in the dedication denying access to Decatur Boulevard from the following described lots, to wit: GOLF RIDGE TERRACE, UNIT NO. 2, LOT 1, BLOCK 10, and GOLF RIDGE TERRACE, UNIT NO. 5, LOTS 2 THROUGH 10, BLOCK 10, be, and the same hereby is, eliminated.


IT IS FURTHER ORDERED that all plats recorded in the Office of the County Recorder of Clark County, Nevada, be altered to reflect said amendment.
