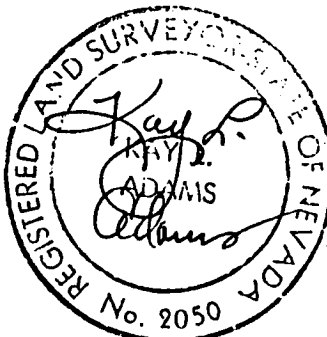
Dear Mr. Peterson:

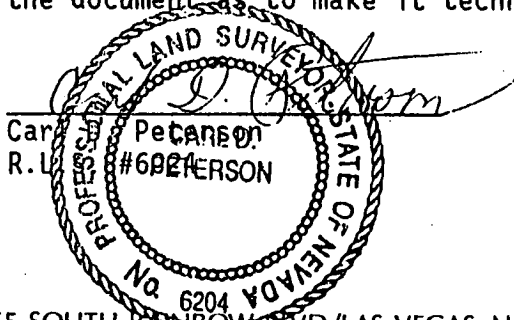
