In accord with my conversations with Mr. Bob Genzer of your office, please be advised that we originally built the above duplexes approximately 4 years ago. At that time they were assigned addresses of 5700 - 5722 and 5800 - 5814.

We recently recorded a final map which converts these duplexes to individual units, which can be sold as such, rather than having to sell them as duplexes. At the time this new final map was recorded, new street addresses were issued, which were different from the original addresses issued. The new addresses were 5700 - 5718 and 5800 - 5818.

Per my discussion with Mr. Genzer, please correct your records to reflect these units with the addresses originally issued to them.

If you need anything further, would you please contact me immediately. I will await written verification of this correction.
