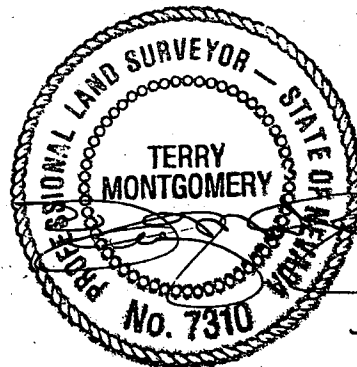

Sheet 2 of 9 - Within the depiction of buildings number 10 and 11 the unit numbers need to read from left to right 11-1, 11-3, 11-2, 11-4 and 10-1, 10-3, 10-2, 10-4 as shown on the attached sketch exhibit "A".

Sheet 5 of 9 - Within the depiction of building number 37 the building type should be changed from a type "A" building to A type "C" building as shown on the attached sketch exhibit "B".

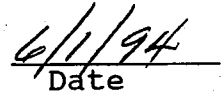

SHEET 2 OF 9 (OF FINAL MAP)

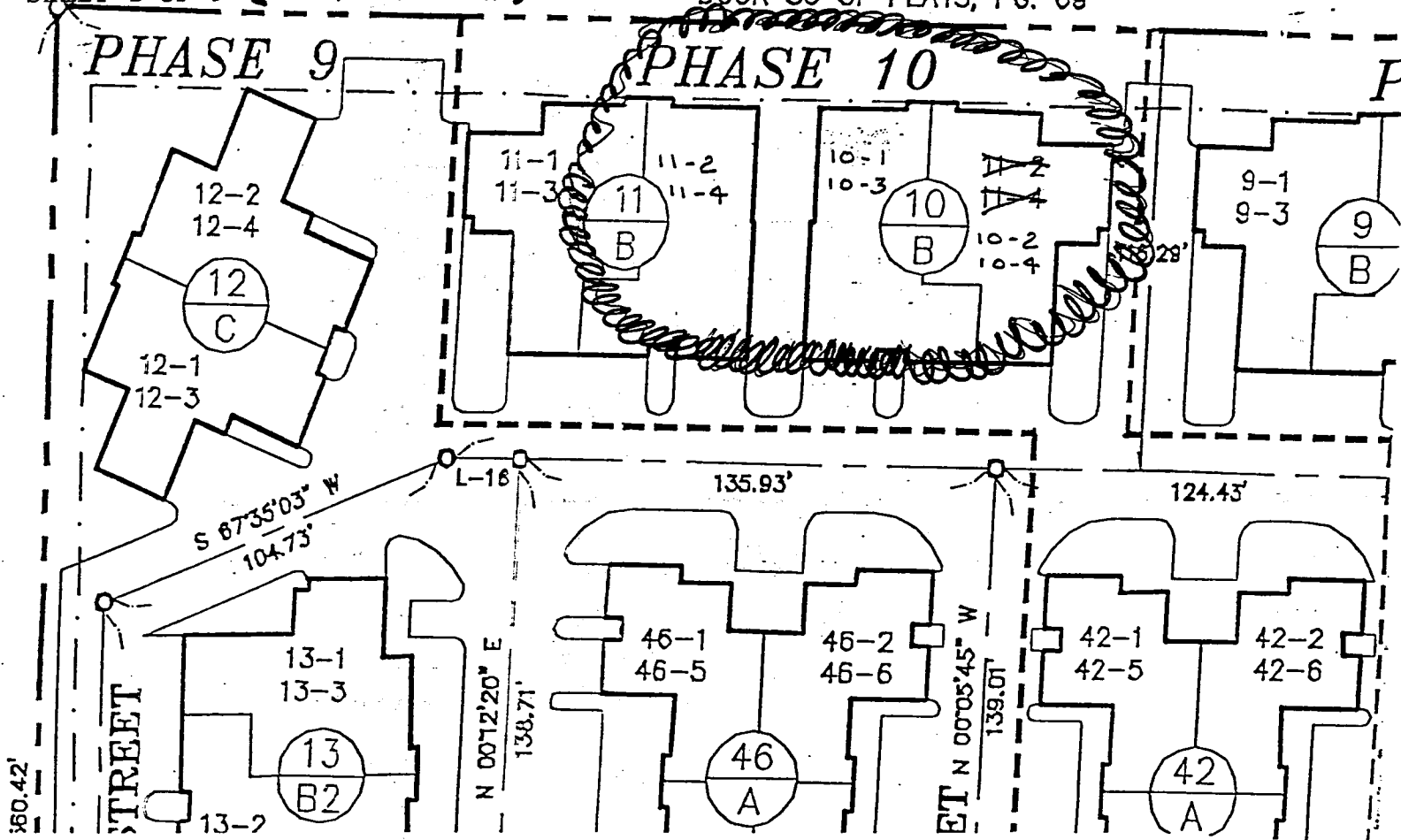
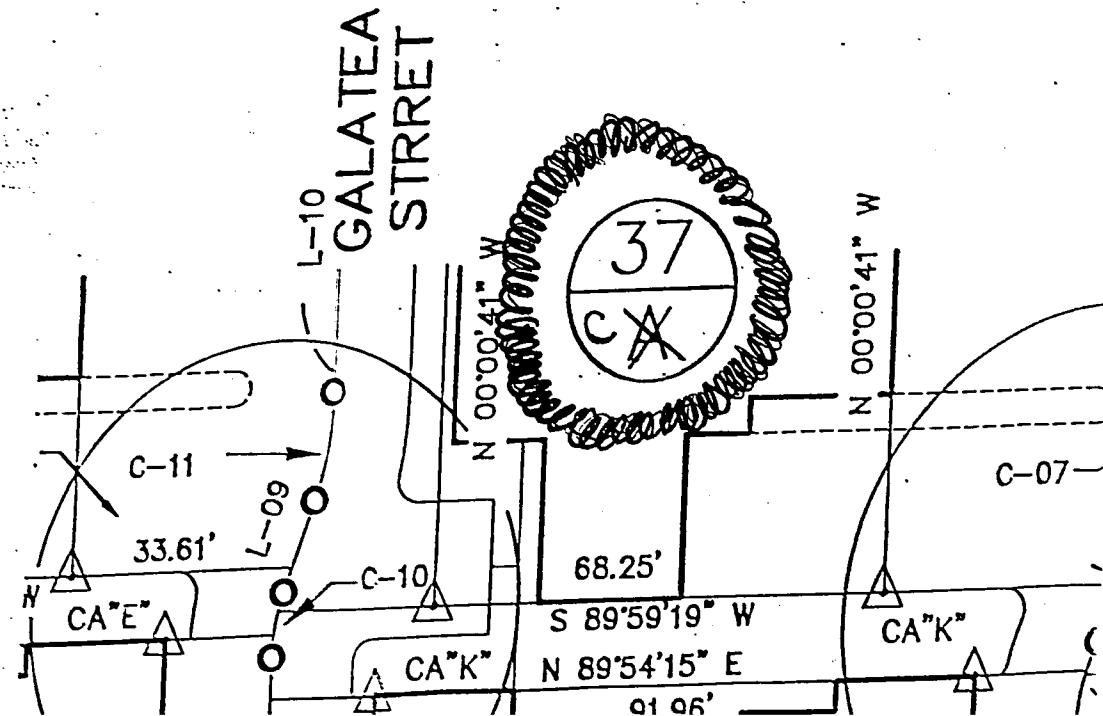
