After examination of Book 30, Page 88 of PLATS on file in the office of the Recorder, Clark County, Nevada, recorded 1/18/84 in Book 1862, Instrument 1821025, I find an amendment to be in order under Nevada Revised Statute 278.473.

The street name appearing on the above referenced plat, also known as "Sunshine Village", is Carter Street. This street name is correct and the location is as shown upon the plat.

The following street names are the subject of this certificate of amendment:

These six street names must be added. The street names have been approved by Ann Vilbert of the Fire Department. The Post Office, Ena, and the original plat must be amended to include the above street names.

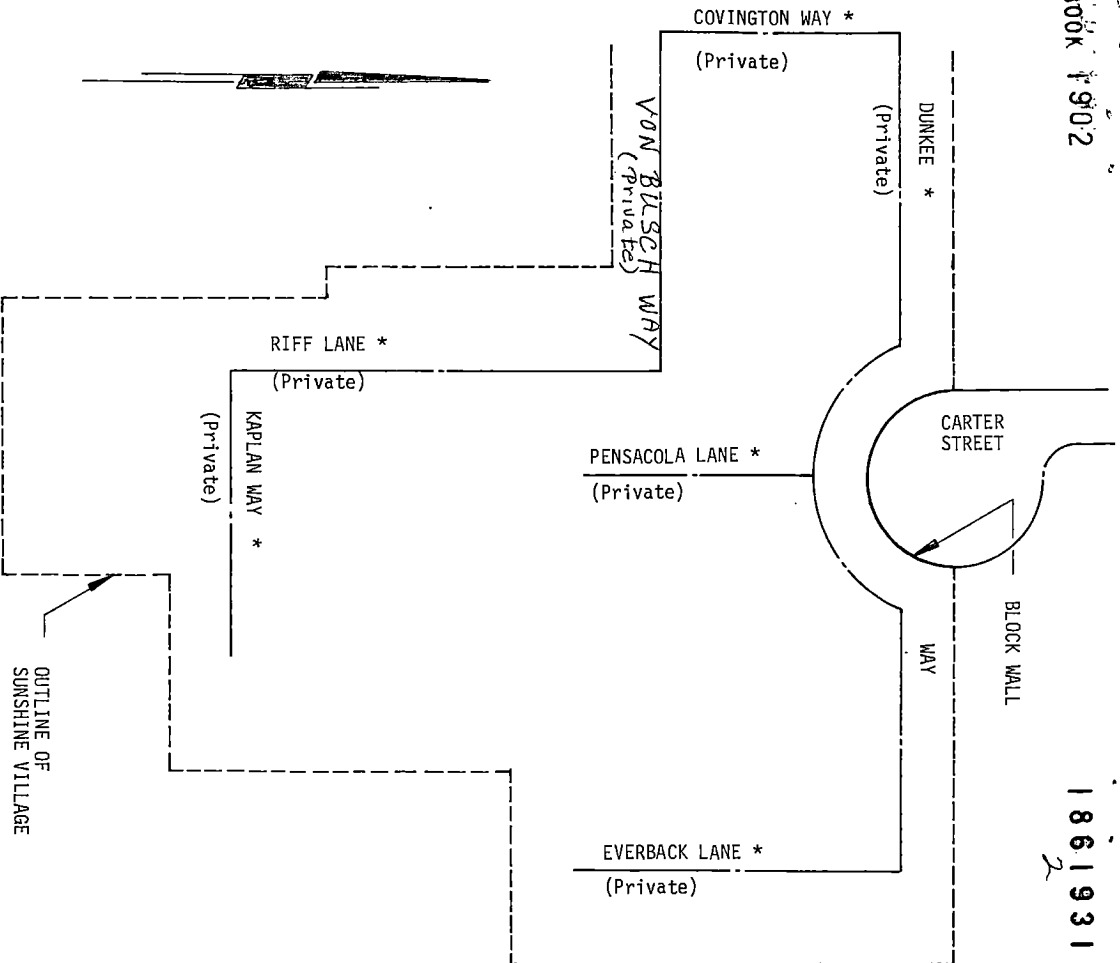
To accomplish this I have drawn an orientation sketch on Page 2. This sketch reflects existing, correct, plat dimensions and should be used to orient and add the omitted street names.

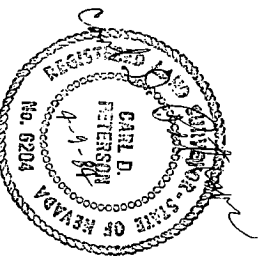
