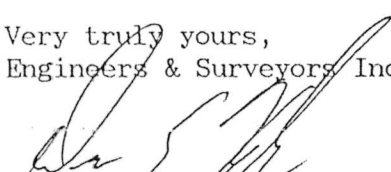

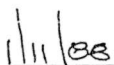
Dear Mr. Peterson,

After examination of the Bluffs Unit No. 9B, as shown by Official Plat in the office of the Clark County, Nevada Recorder in Book 38, Page 46, the following amendments should be made:

Lot 6 of Block 5, a distance on the Easterly property line should be added to read 93.15', Lot 1 of Block 5 the interior distance between C59 and C4 should read 62.80', and Lot 1 of Block 3 the interior distance between C83 and C5 should read 62.41', and Lot 20 of Block 3, C52 should be added between the point of reverse curvature and the Lot line of 19 and 20, and Lot 25 of Block 3, C30 should be added between the point of reverse curvature and the Lot line of 25 and 26, and Lot 30 of Block 3, C24 should be added between the point of reverse curvature and the Lot line of 30 and 31, and Lot 31 of Block 3, C23 should be added between the point of curvature and the Lot line of 30 and 31, and Lot 39 of Block 3, a distance on the Easterly property line should be added to read 58.57'.

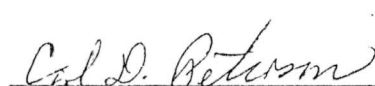

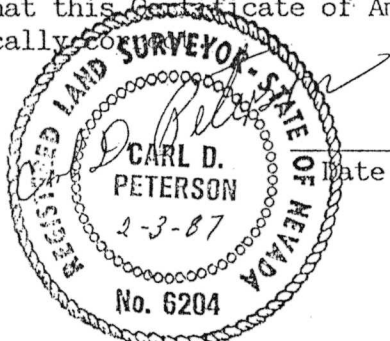
