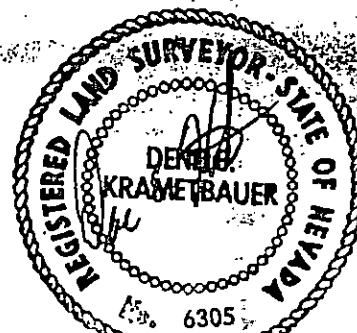

Lots 105 Block 16 the North line distance not shown is 101.14 feet. Lot 106 Block 16 the North line distance not shown is 110.00 feet. In the Curve Data Table Curve No. 75 with a Delta of 06 39' 03" the Length of 36.51 feet changes to 280.30 feet and the Tangent of 18.28 feet changes to 140.32 feet. The street name Canyon Cove Way changes to Canyoncove Way.
