

## RESOLUTION R-21-99

3 A RESOLUTION RELATING TO CITY OF LAS VEGAS, NEVADA, SPECIAL IMPROVEMENT  
4 DISTRICT NO. 707 (SUMMERLIN AREA); APPROVING THE THIRTY-NINTH ASSESSMENT  
5 APPORTIONMENT REPORT WITH RESPECT TO CERTAIN LOTS AND PARCELS OF  
6 PROPERTY WITHIN SAID DISTRICT; AND DIRECTING THE RECORDATION OF SAID REPORT.

8 WHEREAS, the City Council of the City of Las Vegas (the "City Council" and the "City",  
9 respectively, herein), in the County of Clark and State of Nevada, has taken the requisite legal  
10 action that is preliminary to and in the creation of "City of Las Vegas, Nevada, Special Improvement  
11 District No. 707 (Summerlin Area)" (the "District" herein), for the purposes of providing for the  
12 acquisition, construction and installation of street, road, sanitary sewer, storm sewer/drainage  
13 improvements, and water main projects (the "Project" herein), and of defraying the entire costs and  
14 expenses thereof by special assessments against the assessable lots and parcels of property  
15 within the District according to the benefits that would be derived from the Project by the respective  
16 lots and parcels that were to be so assessed, all in accordance with the provisions of Chapter 271,  
17 et seq., of the Nevada Revised Statutes ("NRS" herein) that provide therefor; and

19 WHEREAS, the City Council, pursuant to NRS 271.425, has directed the City Treasurer of  
20 the City (the "City Treasurer" herein) to apportion, upon an equitable basis, the uncollected and  
21 heretofore unapportioned amounts of the special assessments that were heretofore levied upon that  
22 certain lot or parcel of property that is situate within the District and is identified by the Clark County,  
23 Nevada, County Assessor's parcel number as Parcel 137-26-610-001, among the several parts into  
24 which said Parcel has been divided and to prepare, submit and file with the City Clerk of the City (the  
25 "City Clerk" herein) a report of such apportionment; and

27 WHEREAS, the City Treasurer, on the 22nd day of March, 1999, filed with the City Clerk a  
28 copy of his report of such apportionment that is entitled "Thirty-ninth Assessment Apportionment  
Report for City of Las Vegas, Nevada, Special Improvement District No. 707 (Summerlin Area)";  
and

WHEREAS, the City Council has reviewed said Report and has found the same, in all  
respects, to be satisfactory;

1 NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Las Vegas,  
2 Nevada, at this regular meeting thereof that is being held on this 22nd day of March, 1999, as  
3 follows:

4 SECTION 1. That that certain document entitled " Thirty-ninth Assessment  
5 Apportionment Report for City of Las Vegas, Nevada, Special Improvement District No. 707  
6 (Summerlin Area)", a copy of which is attached as Exhibit "A" hereto, is hereby approved and  
7 adopted as and for the City's plan for the apportionment of the uncollected and heretofore  
8 unapportioned amounts of the special assessments that were heretofore levied upon that certain lot  
9 and parcel of property that is situate within the District and is identified by the Clark County, Nevada,  
10 County Assessor's parcel number as Parcel 137-26-610-001, among the several parts into which  
11 said Parcel, has been divided.

12 SECTION 2. That the City Clerk is hereby authorized, empowered and  
13 directed to record in the Office of the County Recorder of Clark County, Nevada, a copy of said  
14 Report, together with a statement that the current payment status of any of the assessments that are  
15 shown thereon may be obtained from the City Treasurer.


