

RESOLUTION ACCEPTING BIDS

WHEREAS, the City Council of the City of Las Vegas, in the County of Clark and State of Nevada, has taken steps to create certain public improvements within said City, all as designated as Las Vegas Special Improvement District No. 458; and

WHEREAS, by resolution passed, adopted and approved on the 1st day of November, 1989, the City Clerk was directed to publish notice of the receipt of bids for the furnishing of labor, materials, transportation and services for the improvements to be installed in each assessment unit of said Special Improvement District No. 458; and

WHEREAS, proper notices were given by publication of the receipt of bids for the furnishing of such labor, materials, transportation and services; and

WHEREAS, bids were received and opened on the 19th day of December, 1989, and confirmation thereof was continued for the purpose of tabulating and reporting the same to said City Council; and

WHEREAS, the time has now arrived to award the construction contracts, in each of the individual assessment units of said District, all in accordance with Chapter 271 of the Nevada Revised Statutes;


NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Las Vegas, Nevada, at a regular meeting thereof held on the 21st day of February, 1990, that the bid of MMC, INCORPORATED in the amount of \$115,143.00, for the improvements to be installed in ASSESSMENT UNIT NO. 1, MMC, INCORPORATED, in the amount of \$48,444.00, for improvements to be installed in ASSESSMENT UNIT NO. II, MMC, INCORPORATED, in the amount of \$114,040.00, for the improvements to be installed in ASSESSMENT UNIT NO. III, MMC, INCORPORATED, in the amount of \$753.00, for the improvements to be installed in ASSESSMENT UNIT NO. IV, MMC,



INCORPORATED, in the amount of \$106,863.00; for the improvements to be installed in ASSESSMENT UNIT NO. V, MMC, INCORPORATED, in the amount of \$59,889.00, for the improvements to be installed in ASSESSMENT UNIT NO. VI, MMC, INCORPORATED, in the amount of \$44,205.00, for the improvements to be installed in ASSESSMENT UNIT NO. VII, MMC, INCORPORATED, in the amount of \$156,914.00, for the improvements to be installed in ASSESSMENT UNIT NO. VIII and MMC, INCORPORATED, in the amount of \$319,730.00, for the improvements to be installed in ASSESSMENT UNIT NO. IX of said District, be, and the same hereby is, accepted.

BE IT FURTHER RESOLVED that the Mayor and City Clerk of said City be, and they hereby are, authorized, empowered and directed to execute any and all documents which may be necessary to carry this Resolution into effect.
